Police Officer Qualifications

The following qualifications are necessary for a candidate to be considered for appointment as a Police Officer for the Clearcreek Township Police Department:

- United States citizen at least 21 years of age.
- Possess a valid Ohio driver license.
- No conviction record for felony, domestic violence, or crime of moral turpitude (Refer to “Disqualification Criteria for Appointment as Police Officer”).
- Have a current Ohio Peace Officer Basic Training Certificate or its equivalent or currently enrolled in a certified OPOTC police academy.
- Be presently commissioned as a Peace Officer, not being out of active police service / school for more than one year (365 days) at the time of appointment as acceptable by the Ohio Peace Officer Training Commission.
- Be in good physical condition to meet the demands in the police service.
- Successfully complete one (1) year probation.

The candidate must successfully complete all phases of the following selection process:

Pre-Testing Application.

- Physical Fitness Assessment (Pass / Fail).
- Written Examination (70% minimum score).
- Oral Interview(s) (70% minimum score).
- Personal History Evaluation.
- Psychological Assessment.
- Polygraph Examination (Pre-Conditional Offer of Employment).
- Final Interview.
- Polygraph Examination (Post-Conditional Offer of Employment).
- Medical Examination.

Steps may be added or waived by the Chief of Police with the approval of the Township Administrator, for just cause.

Pre-Testing Applications for employment as a Part-Time Police Officer may be accepted on an “open basis”, Monday – Friday during regular business hours.
