RE: Public Notice, Public Hearing and Comment Period for Warren County Solid Waste Management District Plan Update

PUBLIC NOTICE

The Warren County Solid Waste Management District (WCSWMD) is establishing a 30-day written comment period (May 15, 2017 – June 15, 2017) on the draft solid waste management plan (Ohio Revised Code Section 3734.55). WCSWMD has prepared a solid waste management plan as required by Section 3734.54 of the Ohio Revised Code.

The solid waste management plan includes a solid waste facility inventory, projections and strategies, facilities and programs to be used, an analysis of progress made toward achieving state waste reduction goals, and costs to finance the plan. This plan is an update to a plan previously written for the WCSWMD by the Ohio EPA and includes descriptions of the following programs: recycling and waste minimization programs, education, curbside recycling, commercial/industrial sector education and recycling, household hazardous waste disposal, and litter collection.

The plan includes a demonstration of access to capacity that determines landfill capacity available to WCSWMD. The District is precluded from establishing facility designations in accordance with Section 343.014 and 3734.53 of the Ohio Revised Code.

WCSWMD currently funds programs largely through waste generation fees received from miscellaneous landfills, such as the Rumpke Landfill located in Cincinnati that accepts waste from the WCSWMD and surrounding districts. No fee changes are anticipated during this draft period.

The draft plan will be available for public review beginning May 15, 2017 at the following locations:
