On 10/1/22, officers responded to the area of Pekin Road for an assault. Officers contacted all subjects involved at the scene. Based on the information provided, both parties agreed to separate, and officers made no arrests for this incident.

On 10/1/22, officers responded to Yankee and Crossley Roads for an intoxicated driver. Upon arrival, officers found the vehicle crashed into a ditch on Crossley Road. The driver was arrested and charged with OVI.

On 10/2/22, officers responded to a domestic complaint on Valleyview Point. Officers made contact with all subjects at the scene and determined no charges would be filed for this incident. Both parties agreed to separate.

On 10/4/22, officers responded to a theft complaint on Country Brook Court. Officers contacted the complainant, who reported three dirt bikes stolen from a detached garage. There are no suspects at this time, and the investigation is ongoing.

On 10/5/22, officers responded to a check theft complaint on Deep Woods Court. Officers contacted the complainant, who reported a cashier's check stolen and cashed by an unknown subject. The investigation is ongoing.

On 10/5/22, officers responded to a theft from a vehicle that occurred on Country Brook Court. Officers contacted the complainant, who reported items stolen from inside the vehicle. The suspects are unknown at this time, and the investigation is ongoing.

On 10/5/22, officers responded to a motor vehicle theft that occurred on Country Brook Court. Officers contacted the complainant, who reported the vehicle stolen from the driveway. The suspects are unknown at this time, and the investigation is ongoing.

On 10/12/22, officers responded to an active domestic on Bennington Way. Officers made contact with all subjects at the scene and determined no charges would be filed for this incident. Both parties agreed to separate, and officers referred the subjects to the Prosecutor's Office due to conflicting statements.

On 10/20/22, officers responded to a report of someone attacked with an axe. Officers contacted all subjects involved, and no injuries were reported. Officers arrested the subject with the axe for aggravated menacing and transported him to the Warren County Jail.

Officers arrived on the scene and discovered a vehicle into a tree and a downed utility pole. Upon further investigation, the officers arrested the driver, who was charged with OVI.






### 2021 - 2022 YTD Calls for Service Comparison
