Each of these officers are proven leaders and we look forward to seeing what the future holds. Again, congratulations and well done!

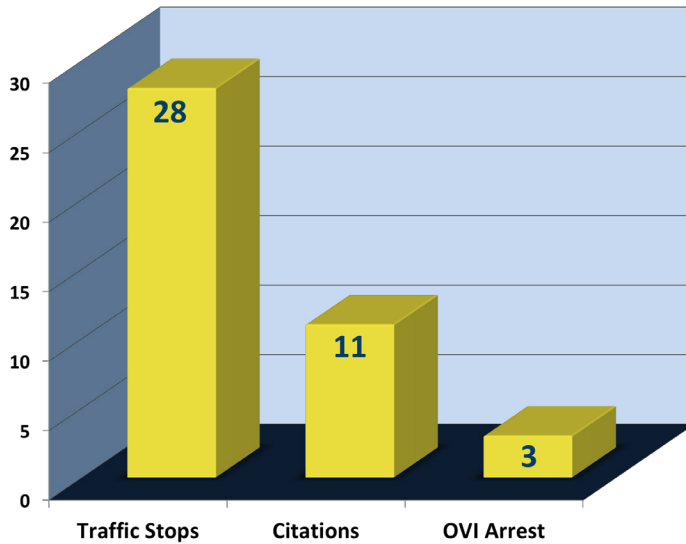

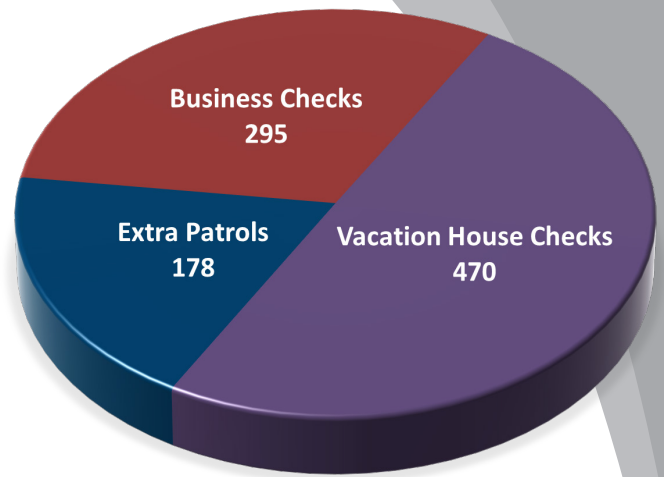

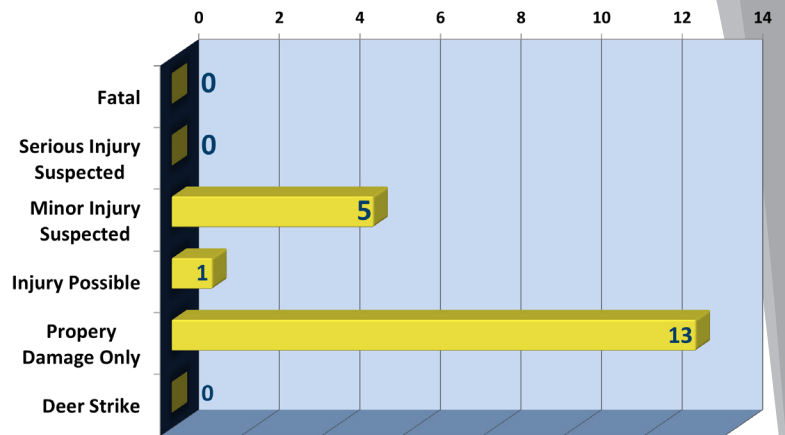
February Calls for Service



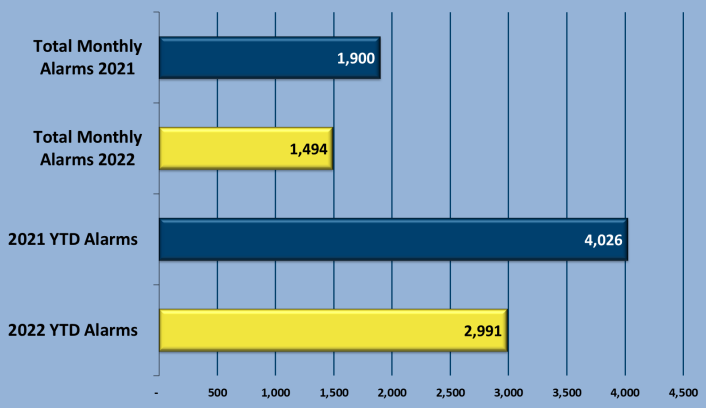

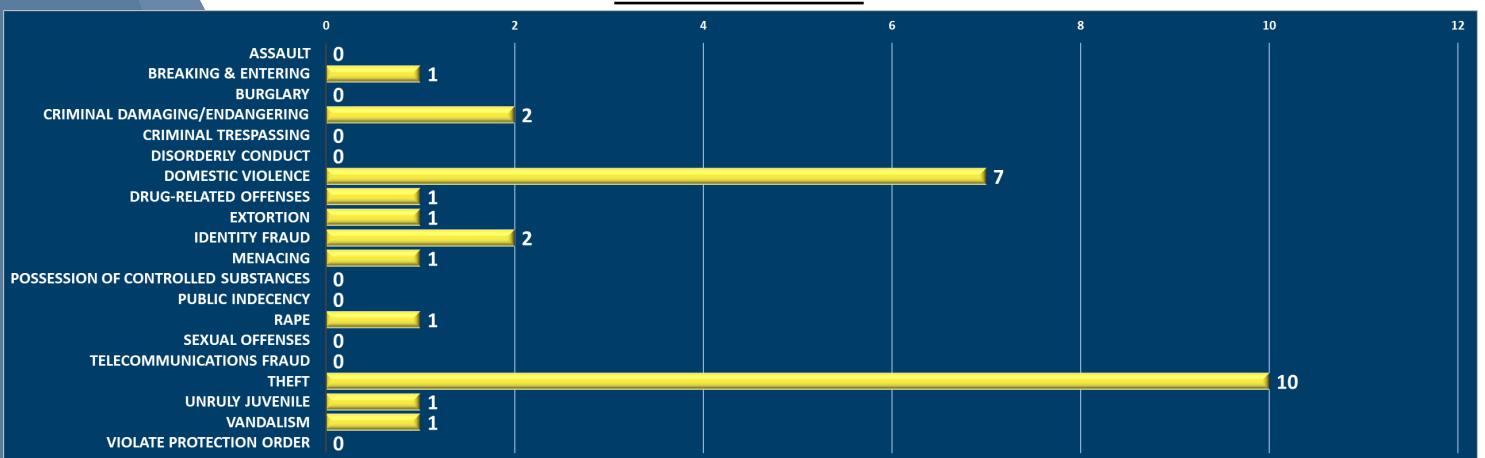
Traffic Collisions By Classification
