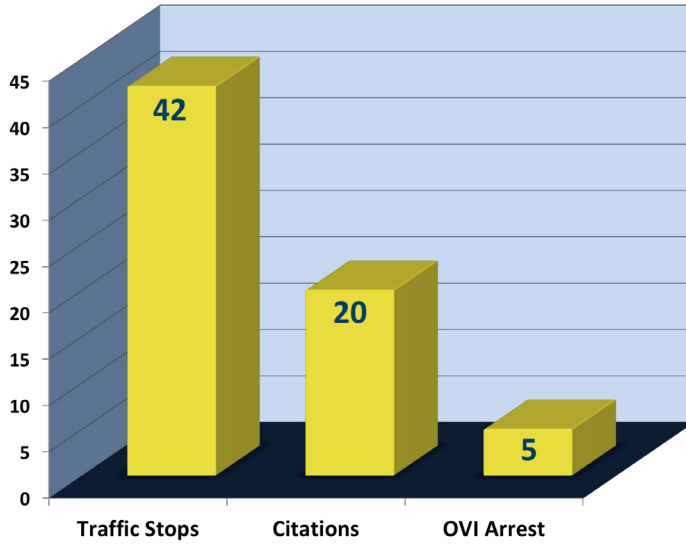

Classes start on 6/13/22 and are free for children ages 6 to 8 who reside within Clearcreek Township or the City of Springboro.

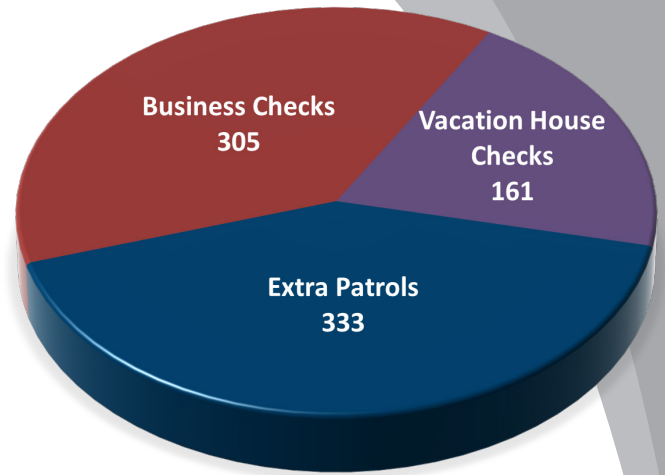

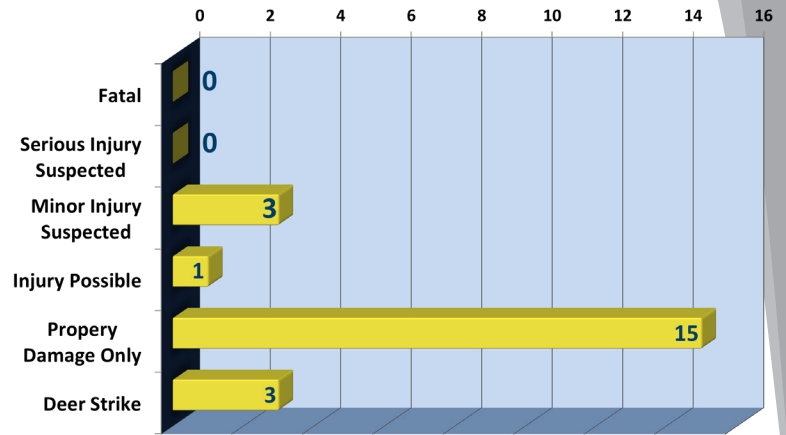
## March Traffic Enforcement



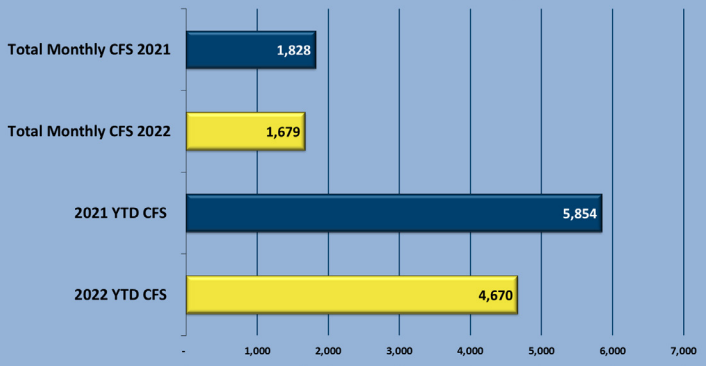
## Crime Prevention Services



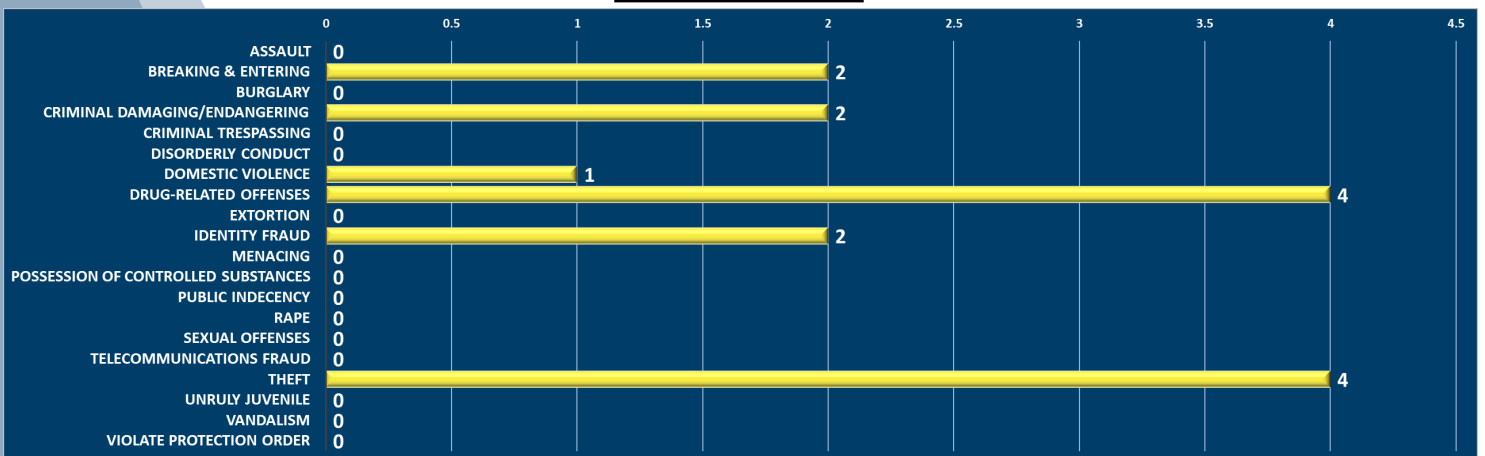
## Traffic Collisions By Classification

# Significant Activity

On 3/4/22 at 3:46 am, Officer McWhorter responded to a suspicious vehicle call at UDF in Red Lion. Officers located the vehicle and spoke with the driver. They found drug paraphernalia inside the car while investigating. The driver was summoned for Possession of Drug Paraphernalia and released.

Officers arranged for a veterinarian to check on the horses and contacted a horse rescue organization to take the horses. Officers charged the owners with Cruelty to Animals.

On 3/18/22 at 1:54 am, Officer McWhorter stopped a vehicle on Bentrige Drive for numerous traffic violations. On further investigation, the driver was arrested for Operating a Vehicle while Intoxicated.

On 3/25/22 at 8:15 am, Sergeant Bates and Corporal Morgan responded to a call of a vehicle pulled into a driveway on North State Route 48 with the driver passed out at the wheel. After investigating, the driver was arrested for Operating a Vehicle while Intoxicated.
