On 07/01/22, officers were dispatched to an impaired driver in the area of Bunnell Hill Road and North State Route 48. Officers were able to stop the vehicle and it was determined that the driver was impaired. The driver was arrested and charged with operating a vehicle while intoxicated.

On 07/05/22, officers were dispatched to the area of Bunnell Hill Road and West Lower Springboro Road for a suspicious vehicle in the roadway. Officers made contact with the driver who they determined was impaired. The driver was arrested and charged with operating a vehicle while intoxicated and open container in a motor vehicle.

On 07/06/22, officers were dispatched to the 100 block of Gertrude Avenue for a sexual offense. Contact was made with the complainant. The investigation is ongoing.

On 07/07/22, officers were dispatched to the 400 block of East Lower Springboro Road for a suspicious person. The complainant advised that she had observed a white male flee down the driveway and continue in an unknown direction. It was determined that a cell phone had been taken from the vehicle. The cell phone was later recovered in the 500 block of East Lower Springboro Road. No suspect has been identified at this time.

On 07/09/22, officers were dispatched to the 9800 block of Winding Creek Boulevard for a vehicle crash with injuries. Officers arrived on scene and determined that the driver of the at-fault vehicle was impaired. The driver was arrested and charged with driving while impaired and for driving left of center on a roadway. All subjects involved in the crash were treated on scene.


On 07/10/22, officers were dispatched to the 2500 block of West State Route 122 for a fight. Officers responded and made contact with the victims and were able to determine the identity of the suspect. Assault charges are pending at this time.

On 07/12/22, officers were dispatched to the 5900 block of North State Route 48 for a domestic violence call. Officers arrived on scene and made contact with the victim and the primary aggressor. Upon attempting to affect an arrest one officer was shot and the suspect was also shot. The suspect was pronounced deceased at the scene and the officer is recovering. The investigation is ongoing.



The subject was charged with assault and misuse of the 911 system for conduct that took place while officers were on scene.

On 07/27/22, officers responded to the 2900 block of West State Route 122 for the report of unauthorized use of a vehicle. The suspect was arrested for unauthorized use of a vehicle and theft of a credit card.


July Traffic Enforcement




2021 - 2022 YTD Calls for Service Comparison
