Monthly Report

January 2023



On 1/7/23, officers were dispatched to a possible intoxicated driver in the 2000 block of East State Route 73. Officers responded to the area and made contact with the driver and complainant. The complainant reported that he had confronted the driver and his passenger regarding passing bad checks at a local business. The driver attempted to flee and struck another vehicle in the lot. Officers determined the driver was impaired. The driver was later arrested and transported to the Warren County Jail for Operating a Vehicle while Under the Influence and Possession of Drug Paraphernalia. The investigation for Passing Bad Checks is ongoing.

On 1/12/23, officers were dispatched to the area of Bourdeaux Way to investigate a complaint of a protection order violation. Shortly after, officers located and arrested the suspect. The suspect was charged with Violation of a Protection Order and transported to the Warren County Jail.

On 1/13/23, officers were dispatched to the area of North State Route 48 and West State Route 122 for an unruly juvenile. The officers responded to the scene and located the suspect. The suspect was charged with Assault on a Police Officer, Resisting Arrest, and transported to the Warren County Jail.

On 1/15/23, officers were dispatched to an active domestic in the area of West Factory Road. Officers made contact with all subjects involved at the scene and based on the information provided, officers arrested the primary aggressor. The suspect was arrested, charged with Domestic Violence, and transported to the Warren County Jail.

On 1/17/23, officers responded to the area of West Lower Springboro Road for a reported theft. Officers made contact with the complainant who stated packages were stolen from the porch. The suspect(s) are unknown at this time and the investigation is ongoing.

On 1/17/23, officers were dispatched to the area of North State Route 48 and West State Route 122 for juveniles fighting. The officers responded to the scene and located the subjects. Upon further investigation, one of the subjects was charged with Assault.

On 1/21/23, officers were dispatched to the area of Little Falls Drive for a suspicious vehicle. Officers arrived on scene and discovered the vehicle had been reported as stolen. The vehicle was recovered and returned to the reporting agency in Montgomery County.

On 1/22/23, while patrolling officers discovered a vehicle in the ditch at North State Route 48 and West Lower Springboro Road. Upon further investigation, officers determined the driver was impaired. The driver was charged with Operating a Vehicle While Under the Influence.










2022 - 2023 YTD Calls for Service Comparison
