Officers took part in county wide training with the Warren County Combined Training Group. This training helps all agencies in the county have cohesive tactics making all personnel and citizens safer.

Officers participated in a range day to work on marksmanship and fundamentals with their firearms.

Lieutenant Stacy, Sergeant Bates, Sergeant Barton, and Police Specialist Gleeson took a course in Public Records put on by the Ohio Association of Chiefs of Police.

On October 18, 2023, Officer Bronnenberg responded to the 1700 Block of Wandering Stream Way for a report of an abandoned vehicle. The registration to the vehicle was checked and the vehicle was found to be stolen out of the City of Dayton. The vehicle was towed to The Clearcreek Township Police Department and was processed for evidence. Investigation ongoing.

On October 20, 2023, Detective Barton and Officer McWhorter assisted the City Of Springboro Police with a vehicle pursuit with a vehicle that had been captured on FLOCK camera to have a stolen license plate. The vehicle entered Clearcreek Township and crashed into a yard at the intersection of West Lower Springboro and Red Lion Five Points Road. The driver of the vehicle was charged with Failure to Comply with Order or Signal of a Police Officer and faces additional charges through the City of Springboro and other agencies.

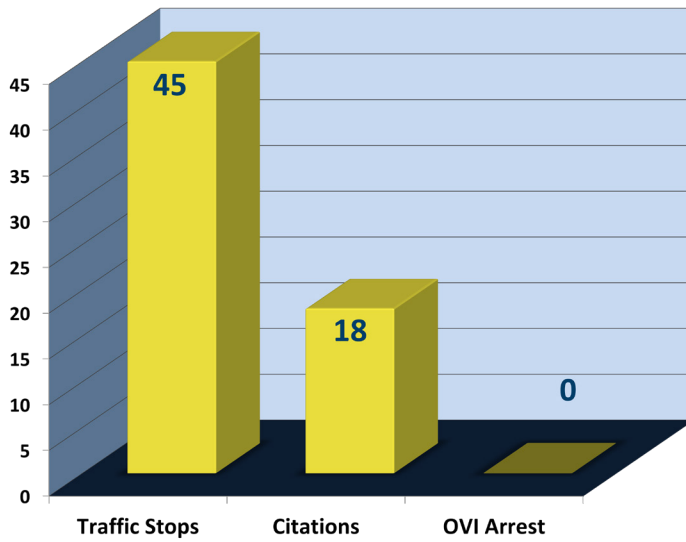

The City of Springboro Police were able to locate the suspect vehicle on South Main Street and performed a traffic stop. The operator of the vehicle was charged with Breaking and Entering and Theft.

On October 25, 2023, Corporal Morgan and Officers S. Williams and McWhorter, assisted the Montgomery County Sheriff's Office locating a stolen vehicle that was found driving in the 9000 Block of Bunnell Hill Road. Upon stopping the vehicle, a juvenile was charged with Receiving Stolen Property and was found to have a handgun in the vehicle.

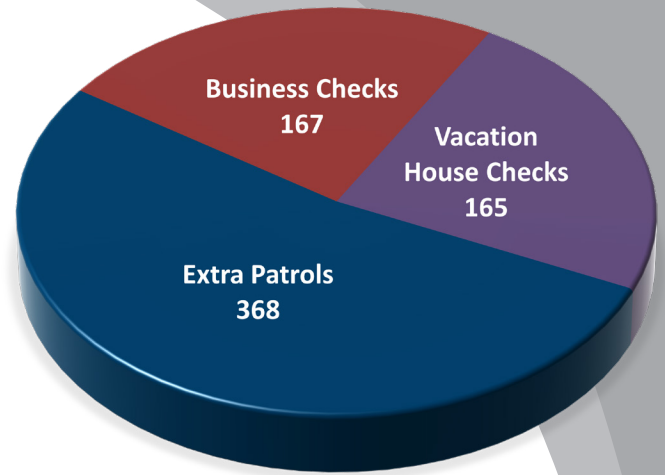

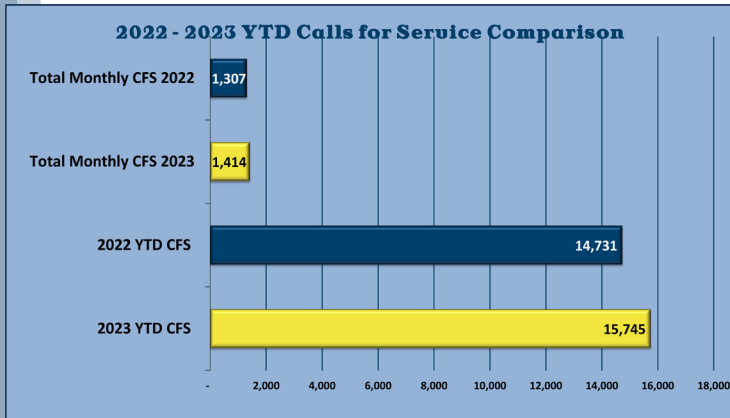

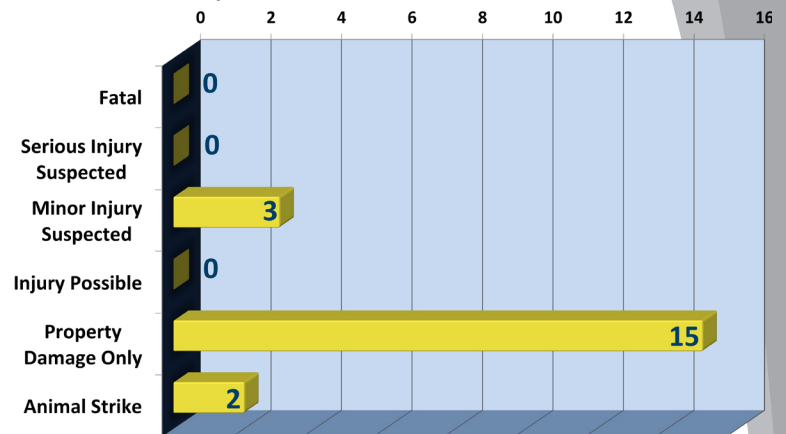

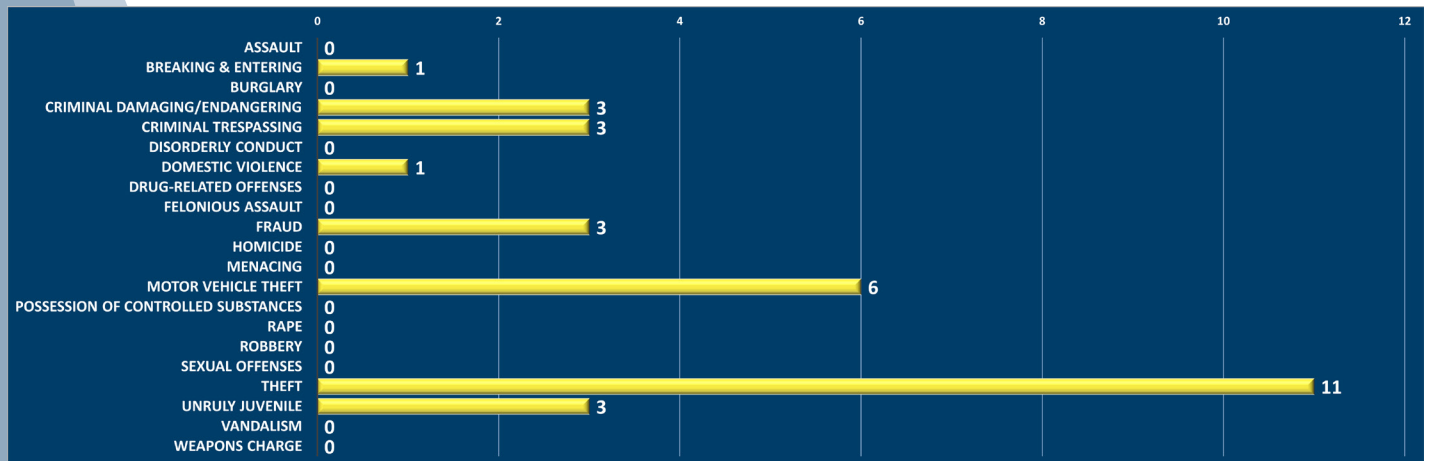
## 2022 - 2023 YTD Calls for Service Comparison
