

# **Clearcreek Police Department**

Monthly Report

November 2023



For the month of November, all officers took part in our annual in-service training where we recertified in less-lethal options such as TASER, OC spray, and baton. We then trained on Active Shooter/Threat Response.

During November, all officers finished their annual State of Ohio Continuing Professional Training requirements for 2023.



On 11/2/23, Officers Hall and Bronnenberg, along with officers from the City of Springboro Police Department, responded to a residence in the 8000 block of Woodbridge Court for a complaint of domestic violence involving a firearm. One suspect left the residence prior to officer's arrival but was quickly located by assisting Springboro Police Officers. Upon investigation, the suspect was charged with Aggravated Menacing and transported to the Warren County Jail.

On 11/2/23, Corporal Blaha and Officer Bronnenberg responded to a residence in the 5600 block of Bunnell Hill road for a complaint of domestic violence. Upon investigation, it was alleged that a suspect had knocked out the complainant's facial piercing, causing injury. The suspect was arrested for Domestic Violence and transported to the Warren County Jail.

On 11/8/23, Officer McWhorter responded to the Warren County Alternative School for a report of an altercation between students. Upon investigation, a juvenile was charged with Disorderly Conduct.

On 11/9/23, Officer McWhorter responded to a residence in the 200 block of East Pekin Road for a well-being check. Upon investigation, officers found the resident had been involved in a domestic incident, was charged with Domestic Violence and transported to the Warren County Jail.



Mid-November, officers took part in a low-light/night range to practice using firearms in dark environments.




On 11/18/23, Corporal Blaha and Officers Schrage and D. Williams, responded to a mutual aid request from the City of Springboro Police for a reported intoxicated driver at Taco Bell on West Central Avenue. The complainant stated there was an unresponsive person in a vehicle, in the drive-thru of the business. Upon investigation, the motorist was arrested for OVI. The motorist submitted to a breath test with the result of .194 BAC, which is more than twice the legal limit in the State of Ohio.

On 11/21/23, Sergeant Bates and Corporal Morgan responded to a complaint of a two-car motor vehicle accident near the intersection of East State Route 73 and North State Route 48. The complainant of the accident advised that one of the vehicles had left the scene prior to officers responding. The operator of the vehicle who left the scene was located and charged with Assured Clear Distance and Leaving the Scene of a Motor Vehicle Accident.

On 11/30/23, Sergeant Sweet and Officer Schrage responded to a complaint of an alleged intoxicated driver in the area of State Route 73 and Bunnell Hill Road. The suspect vehicle was located on East State Route 73 and stopped in traffic, out of gas. Upon investigation, a male motorist was arrested for OVI and driving on a suspended license. The motorist refused to submit to a breath test.




## 2022 - 2023 YTD Calls for Service Comparison




