Monthly Report

December 2023



On December 2, 2023, Sergeant Sweet and Officer Hall responded to a Neighbor Dispute in the 5200 block of Springboro Road. Upon investigation, it was alleged that a male had discharged a firearm in the direction of his neighbors while they were leaving their own property. The male was charged with Felonious Assault, Using Weapons While Intoxicated, and transported to the Warren County Jail.

On December 9, 2023, Officer Hall and Sergeant Sweet responded to the 9700 block of Bunnell Hill Road for a report of a disabled vehicle. Prior to arrival, a second caller advised that it appeared the vehicle had been in a crash. Upon investigation, it was found that the male driver had

damage to his vehicle and had possibly crashed numerous times. The male was charged with OVI and submitted to a breath test to determine his blood alcohol level. The results of the test were .167, which is twice the legal limit of .08. The male was charged with OVI and Operating Without Reasonable Control.

On December 10, 2023, Officers Hall and Schrage responded to a residence in the 6900 block of North State Route 48 for a report of Domestic Violence. Upon arrival, a male suspect began physically fighting with the first arriving officer. Upon further investigation, it was found the male allegedly pushed a female down a flight of stairs in the residence, causing injury to the female. The male was arrested for Domestic Violence, Assault on a Police Officer, and Resisting Arrest. The male was transported to the Warren County Jail.

On December 21, 2023, Sergeant Sweet and Officer Bronnenberg responded to a residence in the 9500 block of Aspen Brook Court. Upon investigation, a female allegedly assaulted a male during an argument. The female was arrested for Domestic Violence and was transported to the Warren County Jail.



On December 25, 2023, Officers Hall and Bronnenberg responded to a one car accident, with injuries, in the 1500 block of West State Route 122. Upon investigation it was found that three juvenile passengers were injured and transported to the hospital for treatment. The male driver of the vehicle was charged with OVI, Operating Without Reasonable Control, and Endangering Children. The male refused to submit to a blood alcohol test and was transported to the Warren County Jail.




All officers completed a Dealing with the Mentally III training in December.


December Traffic Enforcement



2022 - 2023 YTD Calls for Service Comparison




Crime Prevention Services
