On 5/24/23, Sergeant Cordero and Officer Ney received the EMS Star of Life Award, along with Clearcreek Fire District Crews, 911 dispatchers from Warren County Communications, and CareFlight. On 5/4/23, officers were dispatched to the area of Red Lion Five Points Road and Hickory Point for a well-being check. Officers approached the vehicle and observed a white male slumped over the wheel and what appeared to be a firearm resting in his hand. The male was later able to be roused with the assistance of the Warren County Tactical Response Team and he was taken into custody. It was later determined the driver was not impaired but found to be in possession of a possible controlled substance. Charges are pending the chemical analysis results of the substance and the driver was released on his own recognizance.

On 5/4/23, officers responded to a harassment complaint in the area of North State Route 48 and State Route 122. Officers made contact with the complainant who reported to being threatened by a male subject. The subject was located and admitted to threatening the complainant. The male was charged with disorderly conduct and transported to the Warren County jail.

On 5/4/23, officers responded to a theft complaint in the 7900 block of North State Route 48. Officers made contact with the complainant who reported a contractor was paid to perform work on their residence and no work was completed. The investigation is ongoing.

On 5/7/23, officers responded to a criminal damaging complaint in the 7800 block of North State Route 48. Officers made contact with the complainant who reported damage to his yard from a neighbor's truck. The suspect was identified and trespassed from the property. No charges were filed for this incident.

On 5/8/23, officers responded to a disorderly conduct complaint in the area of North State Route 48 and State Route 122. Officers made contact with all subjects involved at the scene and based on the information provided both subjects were charged with disorderly conduct for engaging in fighting.

On 5/10/23, officers responded to a theft complaint in the 900 block of East Lower Springboro Road. Officers made contact with the complainant who reported a theft of a musical instrument from a building. There are no suspect(s) at this time and the investigation is ongoing.

On 5/16/23, officers responded to a theft complaint in the 9000 block of North State Route 48. Officers made contact with the complainant who reported theft of tools from company vehicles. There are no suspect(s) at this time and the investigation is ongoing.

On 5/18/23, officers were dispatched to the area of Deerfield Trail for a mental disorder. Officers were responding to the scene when dispatch advised one of the subjects left the residence. Officers later initiated a traffic stop on a vehicle matching the description. While investigating, officers determined the driver to be impaired. The driver was charged with operating a vehicle while under the influence, driving under suspension, and released on his own recognizance. The subject was later transported to another location for additional services.

On 5/23/23, officers responded to an assault complaint in the 5000 block of Red Lion Five Points Road. Officers made contact with all subjects involved at the scene and based on the information provided, both subjects were charged with disorderly conduct for engaging in fighting.

On 5/27/23, officers were dispatched to a crash in the area of Hillcrest Drive. While responding to the crash, officers were advised that the driver fled the scene and was driving toward Bunnell Hill Road. Officers initiated a traffic stop that matched the description of the vehicle. While investigating, officers determined the driver to be impaired. The driver was charged with operating a vehicle while under the influence, driving under suspension, and leaving the scene of a crash.


On 5/27/23, officers were dispatched to a suspicious person at the 2800 block of West Lower Springboro Road. Dispatch advised a male subject was going through vehicles in the area and walking around on the complainant's property. Officers arrived in the area and located a male subject matching the description. When officers identified themselves and commanded the subject to stop, the male fled on foot. The subject was later taken into custody and charged with criminal trespassing, obstructing official business, and transported to the Warren County Jail.

On 5/27/23, officers responded to a theft complaint in the area of Shoemaker Road. Officers made contact with the complainant who reported credit cards stolen from a purse. There are no known suspects at this time and the investigation is ongoing.




2022 - 2023 YTD Calls for Service Comparison




