Significant Activity

On 07/05/23, Sergeant Cordero responded to the 5500 block of Whispering Way for a report of threats of violence towards the complainant. A male will be charged with Aggravated Menacing in regards to the incident.

On 07/05/23, Corporal Blaha, Officer D. Williams, and Sergeant Cordero responded to the UDF at 2585 West State Route 122, for a report of a possible intoxicated driver that had been reported by a witness to make numerous traffic violations on West State Route 122. The suspected vehicle was found parked at the business and officers made contact with the motorist. Upon investigation the female motorist was charged with Operating a Motor Vehicle while Intoxicated.

On 07/09/23, Sergeant Cordero and Officer Schrage responded to the 2600 block of West State Route 122, for a report of an injury crash. Prior to officer's arrival, a male motorist fled the scene of the crash. Officers were assisted by the City of Mason Police Department's K-9 unit. Officers were unable to locate the motorist at the time of the incident but were able to obtain the identity of the motorist through further investigation. The male motorist will be charged with Obstructing Official Business, Operation without being in Reasonable Control, and Stopping after a Motor Vehicle Accident.

On 07/10/23, Sergeant Cordero responded to the UDF at 2585 West State Route 122 for a report of a female laying on the ground. Upon investigation it was found the female had an active warrant out of Brown County, Ohio, for Probation Violations. The female was transported to the Warren County Jail and placed on a hold for Brown County.

On 07/12/23, Sergeant Cordero assisted the Springboro Police Department, as well as other agencies from Warren County, Montgomery County and Clinton County, with the pursuit of a motorist refusing to stop for a traffic violation. The pursuit ended in Clinton county where a male driver was arrested.

On 07/13/23, Officer Morgan responded to the 9100 block of Yankee Road for a report of Criminal Trespass for a male mowing on the complainant's property. Upon investigation a male was charged with Criminal Trespass.

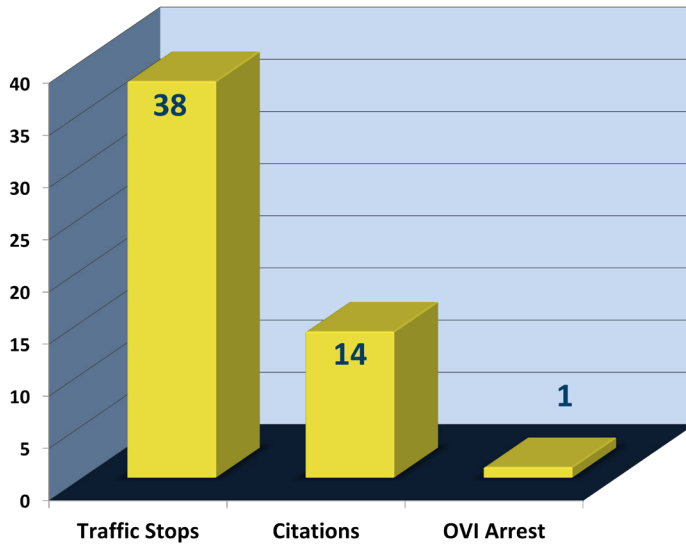

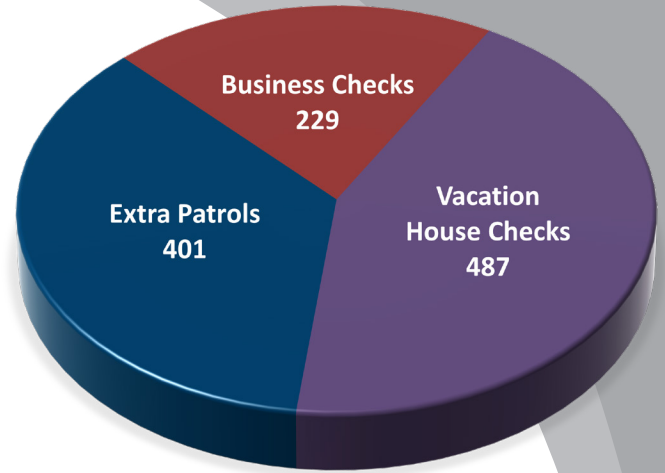

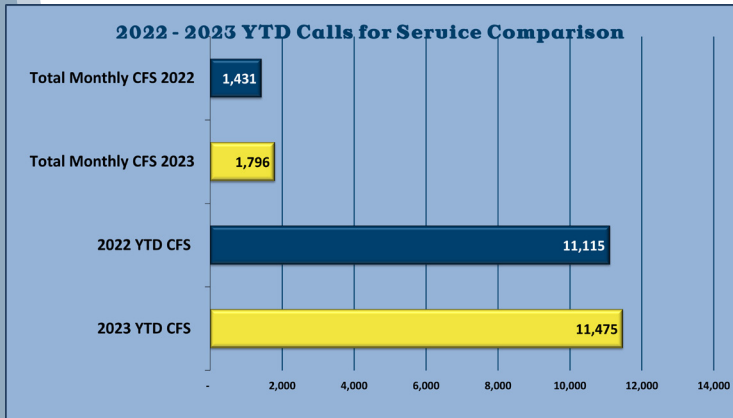

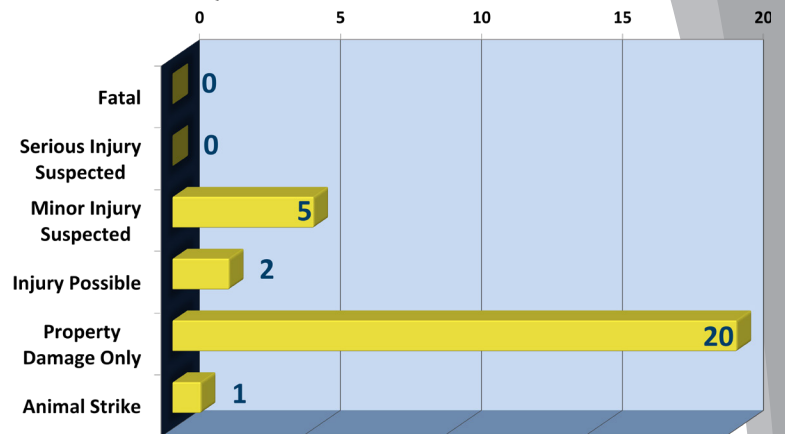

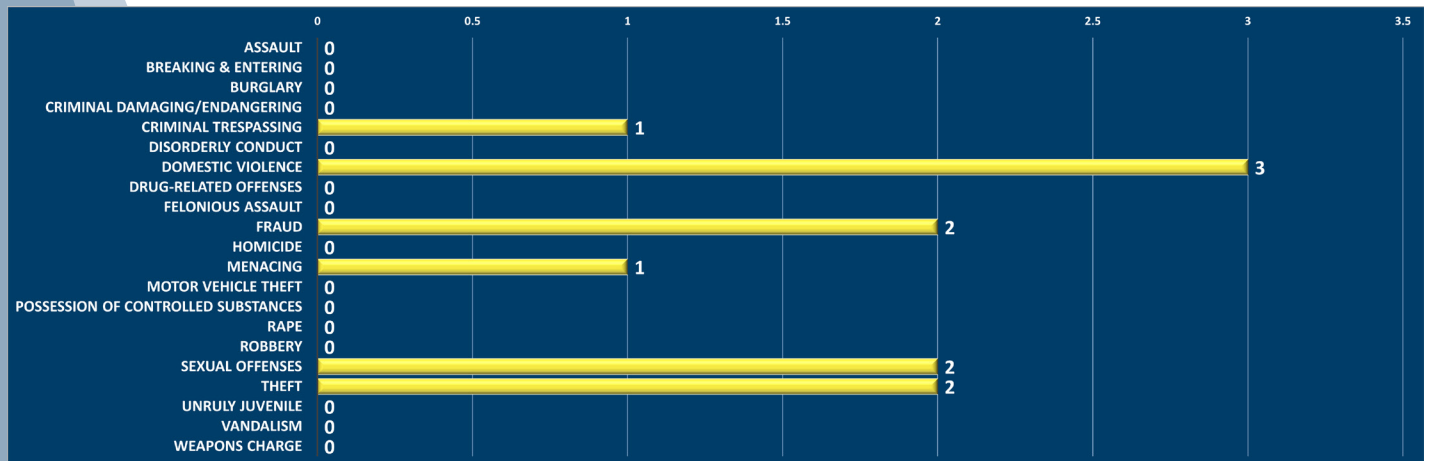
2022 - 2023 YTD Calls for Service Comparison
