On 8/1/23, Clearcreek Police Department hosted National Night out at Patricia Allyn Park. Thank you to Sergeant Cordero, Administrative Clerk Highley, our volunteers, donors and everyone who helps make this annual event a success.



### Excellence *via* TRAINING

All officers worked on 'Use of Body-Worn Cameras' and 'Ethics and Professionalism' through Ohio Peace Officer Training for continuing professional training.

Sergeant Sweet, Corporal Morgan, and Corporal Blaha completed Command Leadership Institute through FBI Law Enforcement Executive Development Association. This training completes Sergeant Sweet's Trilogy for FBI-LEEDA.



## ***Significant Activity***

On 8/2/23, Corporal Blaha and Officer Clay were dispatched to the area of North State Route 48 and East Lytle Five Points for a welfare check of a male reportedly slumped over the wheel in his vehicle. Upon investigation, the male motorist was charged with OVI. The male was taken to the Warren County Jail where he refused to submit to a chemical test.

On 8/13/23, Officers Schrage and D. Williams responded to the 9600 block of Linden Brook Drive for a report of a female assaulted by a male. Upon investigation a male was charged with Assault and was transported to the Warren County Jail.

On 8/15/23, Officer Bronnenberg responded to the 8100 block of Bunnell Hill Road for a report of a one car motor vehicle accident. Upon investigation, the male was charged with OVI and Failure to Control. The male was found to have a blood alcohol level of .153, which is over the legal limit of .08

On 8/15/23, Sergeant Bates, Officers McWhorter and Robinson, and Detective Barton responded to the 2100 block of Harlan Road, for a report of a male that had overdosed on narcotics. Officers administered Narcan to the male at the scene and assisted medics upon their arrival. The male was transported to the hospital for treatment and was later charged with Possession of a Controlled Substance and Possessing Drug Abuse Instruments.

On 8/18/23, Officer Bronnenberg assisted the City of Lebanon Police Department, and the City of Springboro Police Department, with a vehicle pursuit that the City of Lebanon Police Department had when they attempted to stop the vehicle in Lebanon. Upon finding the vehicle at the intersection of North Main Street and East Central Avenue, Officer Bronnenberg activated his emergency lights and attempted to stop the vehicle. The vehicle failed to comply and sped away from the officer. A short vehicle pursuit occurred which resulted in the male motorist losing control of his vehicle, narrowly missing another vehicle in the opposite lane of travel and crashing on the side of the road flipping his vehicle over. The male motorist was transported to the hospital for treatment and was charged with Failure to Comply with Order of a Signal of a police officer and faces numerous other charges from other jurisdictions.

On 8/22/23, Sergeant Cordero and Officer Clay responded to a one car motor vehicle crash in the 6600 block of North State Route 48. Upon investigation, a female motorist was arrested for OVI, Operating a Motor Vehicle without a Valid License, and Failure to Control. The blood alcohol level of the female motorist was found to be 0.174, which is over the legal limit of 0.08.

On 8/20/23, Sergeant Cordero, Corporal Blaha, and officers D. Williams and Schrage, responded to the 1700 block of East Lytle Five Points Road, for a report of a male with a gunshot wound. Upon investigation it was found the male had shot himself and required immediate medical attention. Officers assisted medics with providing aid. Charges have been filed against the male for Having Weapons under Disability.

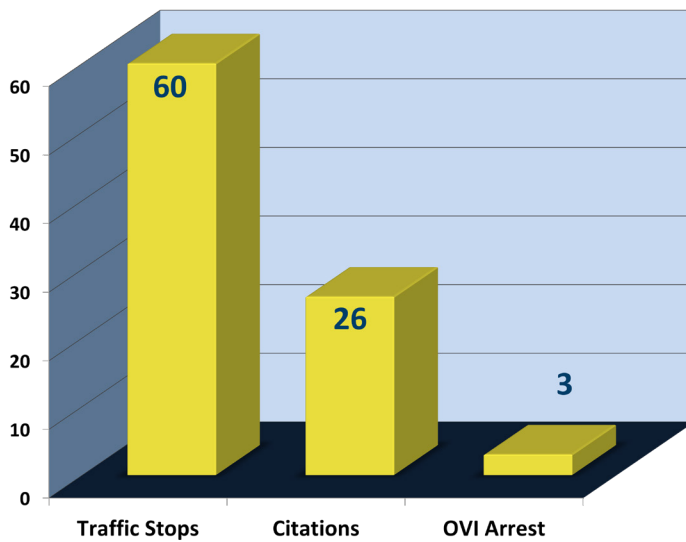

Upon investigation it was found that a male subject had allegedly made threats towards his female spouse. A warrant was issued for the male and the male later turned himself in on domestic violence charges.

On 8/30/23, Sergeant Bates conducted a traffic stop on a speeding motorist on West Lytle Five Points Road. Upon investigation, the male motorist was found to have an active warrant for failure to appear to court and driving without a license.

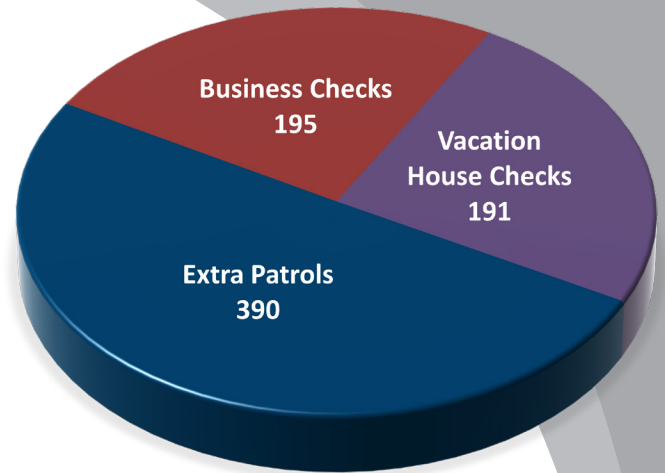

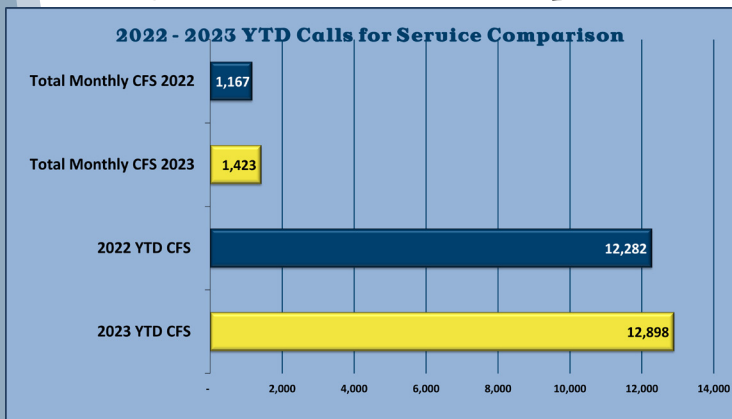

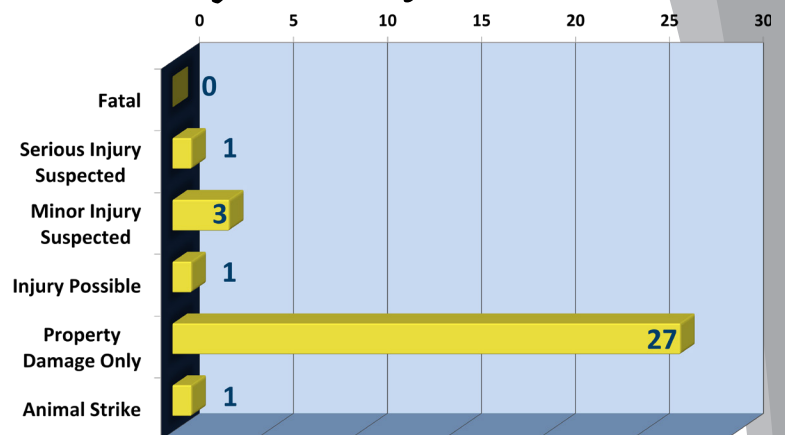

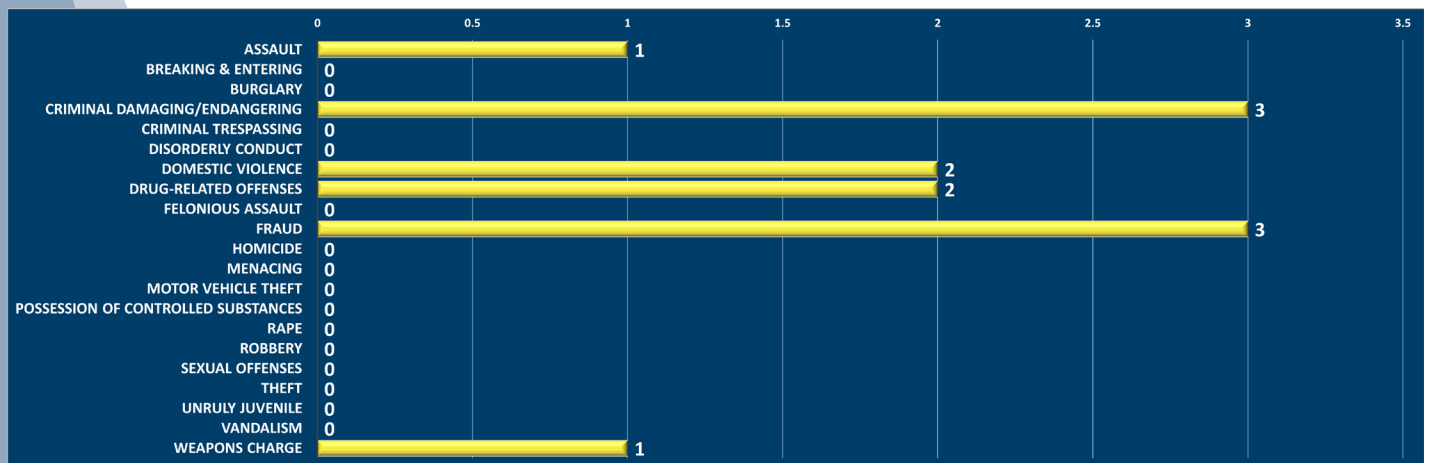
# 2022 - 2023 YTD Calls for Service Comparison
