Significant Activity

On April 28, 2024, Corporal Blaha was advised by dispatch of a report of an intoxicated driver, traveling westbound on East State Route 73, who had committed several traffic violations. The vehicle was located, and a traffic stop was initiated. Upon investigation, the male motorist was placed under arrest for OVI, Driving in Marked Lanes, and Operating a Motor Vehicle without a Valid Driver's License.

On April 24, 2024, Officer McWhorter responded to the Warren County Alternative School for a report of an assault. Upon investigation, it was found that three students had been throwing items in a classroom and one of the items had struck a teacher. Three juvenile students were charged with Disorderly Conduct and will appear in Warren County Juvenile Court at a later date.

On April 22, 2024, Sergeant Sweet, and Officers Bronnenberg and Hall, were dispatched to a well-being check in the 4800 block of Abbey Court. Dispatch advised that a male at the residence called 911, stated he had a drinking problem, and then hung up on the dispatcher. Upon arrival, the male caller was verbally argumentative with officers, appeared to be intoxicated, and told officers to leave. Officers left the residence but noticed the male driving his vehicle a short time later. Due to the apparent intoxication of the male minutes earlier, a traffic stop of the vehicle was initiated. Upon further investigation, the male was arrested for OVI and transported to the hospital for medical evaluation.

On April 21, 2024, Officer D. Williams responded to the 2800 block of Beal Road for a motor vehicle crash. Upon arrival, it was found that a vehicle had driven off the side of the road onto an embankment. Officers on scene detected the smell of an alcoholic beverage coming from the juvenile female driver. Upon further investigation, the female was placed under arrest for OVI, and was found to have a blood alcohol content of .103.

On April 13, 2024, Officer Bronnenberg was on routine patrol in the area of the B&B carryout, located at 2028 East State Route 73, when he observed a vehicle leave the business without working headlights. A traffic stop was initiated, and the officer detected the odor of an alcoholic beverage on the male driver's breath. Upon further investigation, the male was arrested for OVI, and was found to have a blood alcohol content of .09. Two juveniles in the vehicle were also charged for Underage Consumption.

On April 10, 2024, Officers Robinson and McWhorter responded to the Warren County Alternative School to assist the Butler County Sheriff's Office with executing an arrest warrant on a male juvenile. Upon contact with the male, he became argumentative with the officers and refused to comply with verbal orders. The male then actively resisted the officer's attempt to place him in handcuffs. Officers were able to detain the male for the arrest warrant and additionally charged him with Resisting Arrest.


On April 7, 2024, Officer D. Williams responded to the 8600 block Of Ridge Creek Court in reference to a suspicious vehicle that had followed the complainant home. Upon arriving in the area, officers located a vehicle driving in the area that matched the description of the suspicious vehicle. A traffic stop was initiated, and the officer detected the odor of an alcoholic beverage on the driver's breath and person. Upon further investigation, the male driver was charged with OVI, and was found to have a blood alcohol content of .148.

On April 1, 2024, Sergeant Cordero and Officer Schrage responded to a residence in the 7700 block of North State Route 48 for a report of domestic violence. Dispatch advised responding officers that a juvenile male was destroying the house and was in possession of a knife. Upon arrival, officers located the juvenile male outside of the residence and detained him for safety. Upon further investigation, the male was arrested for Domestic Violence and Criminal Damaging.






Calls for Service 2023 - 2024 YTD Comparison
