Significant Activity

On March 16, 2024, Sergeant Sweet and Sergeant Cordero, responded to Game Day Bar and Grill, located at 7576 N. St. Rt. 48, for a suspicious male refusing to leave the business after closing. During the trespass investigation, the male suspect refused to provide his personal information to the officers. The male was later identified and charged with Disorderly Conduct while intoxicated, as well as criminal trespass, and was transported to the Warren County Jail.

On March 24, 2024, Officer McWhorter observed a speeding motorist on North State Route 48 and West State Route 122. Upon attempting to stop the motor vehicle for the violation, the vehicle fled northbound on State Route 48, failing to comply with the officer's emergency equipment ordering him to stop. The vehicle fled on North State Route 48, through a subdivision, and back onto North State Route 48. Dispatch advised officers that the vehicle that was being pursued was reported stolen out of Goshen, Ohio. Officers lost visual of the vehicle in Centerville, terminating the pursuit and surrounding agencies were notified of the vehicle.



Upon investigation, it was found that the male was sleeping in his vehicle and had earlier consumed alcoholic beverages. The male performed field sobriety tests and was found not to be legally impaired. The male was summonsed to court for an open container of an alcoholic beverage in a motor vehicle.

On March 29, 2024, Officer Bronnenberg responded to a possible sex offense between two juveniles in the 6000 block of Bunnell Hill Road. Childrens services and Detective Barton are assisting in the investigation.






Calls for Service 2023 - 2024 YTD Comparison
