On May 25, 2024, Corporal Blaha and Officer Schrage responded to the area of North State Route 48 and Spring Blossom Drive for a report of a one-vehicle rollover crash. Upon arrival, officers noticed an odor of an alcoholic beverage on the male motorist. Field sobriety tests were performed by the male, and upon further investigation, the male was charged with OVI and Operation Without Reasonable Control.

On May 22, 2024, Sergeant Sweet and Officer Bronnenberg responded to the area of Bunnell Hill Road and Shadow Lake Way for a report of a motor vehicle crash. Prior to officers' arrival, a witness on the scene said the male motorist was hiding items behind a decorative stone wall near the crash scene. Upon arrival, officers noticed an odor of an alcoholic beverage and bloodshot eyes on the male motorist. Field sobriety tests were performed by the male, and upon further investigation, the male was charged with OVI, Operation Without Reasonable Control, and Littering. The results of the male's BAC test was .115.

On May 18, 2024, Sergeant Cordero and Officer Schrage responded to a report of a motor vehicle crash in the 7000 block of Bunnell Hill Road. Upon arrival, officers contacted the male motorist and noticed an odor of an alcoholic beverage coming from his person. Field sobriety tests were performed by the male, and upon further investigation, the male was charged with OVI, Operation Without Reasonable Control, and Improperly Handling Firearms in a Motor Vehicle.

On May 16, 2024, Officer D. Williams responded to the 6000 block of Weidner Road for a report of a one-vehicle crash. Upon arrival, a female motorist told the officers that she



had been drinking that evening and should not have driven. Field sobriety tests were performed by the female. Upon further investigation, the female was charged with OVI, Operating a Motor Vehicle Without a Valid License, and Operation Without Reasonable Control.

On May 16, 2024, Sergeant Cordero, Corporal Blaha, and Officer D. Williams responded to a residence in the 200 block of Old 122 Road for a report of domestic violence. Upon arrival, officers interviewed the female resident, who stated that a male who lives with her at the residence had bitten her on the stomach during an argument. Officers checked the female for injuries and found an injury that was consistent with her allegation. The male was charged with Domestic Violence and transported to the Warren County Jail.


On May 3, 2024, Sergeant Cordero and Officer Schrage responded to Utica Road for a report of a motor vehicle crash. Upon arrival, officers noticed an odor of an alcoholic beverage and dilated pupils on the female motorist. Field sobriety tests were performed by the female, and upon further investigation, the female was charged with OVI and Operation Without Being in Reasonable Control.

On May 2, 2024, Officers Bronnenberg and Hall responded to the 5600 block of North State Route 741 for a report of a one-car motor vehicle crash. Upon arrival, officers found a vehicle that had crashed into a utility pole with electric lines touching the vehicle. After the scene was deemed safe by members of the Clearcreek Fire Department, the male exited the vehicle to speak with officers. Officers noticed an odor of an alcoholic beverage and slurred speech coming from the male. The male declined to perform field sobriety tests, and upon further investigation, the male was charged with OVI and Operation Without Being in Reasonable Control.






Calls for Service 2023 - 2024 YTD Comparison
