On the Call

Significant Activity

On July 7, 2024, Corporal Blaha and Officer D. Williams responded to the 9800 Block of Clearcreek-Franklin Road for a report of a vehicle parked on the edge of the road with a male motorist slumped over the wheel. With the assistance of Clearcreek Township Medics, responders were able to wake the motorist, but he was still unable to communicate. The male was transported to the hospital for medical evaluation. Upon further investigation, the male was charged with Having Physical Control of a Motor Vehicle while Under the influence of a drug or alcohol.

On July 10, 2024, Officer Hall and Corporal Knobbe responded to the 100 block of Diamond Drive to assist a male with a child exchange. While on scene, it was alleged that the male that the officers were assisting was operating a vehicle that belonged to a rental company and that the vehicle was stolen. Upon investigation, the male was charged with Receiving Stolen Property and transported to the Warren County Jail.

On July 10, 2024, Sergeant Bates received a complaint from a female resident in the 5600 block of Bunnell Hill Road regarding damage that had been received to her hot tub. Upon investigation, charges were filed against a male for Criminal damaging.

On July 18, 2024, Corporal Morgan responded to the 9600 block of Crooked Creek Drive for a motor vehicle theft. The complainant advised that sometime overnight his vehicle was stolen. Upon investigation, the vehicle was located by the City of Dayton Police on July 25, 2024. The vehicle was taken to the Clearcreek Township Police Department and was processed for evidence. The vehicle was returned to its owner.

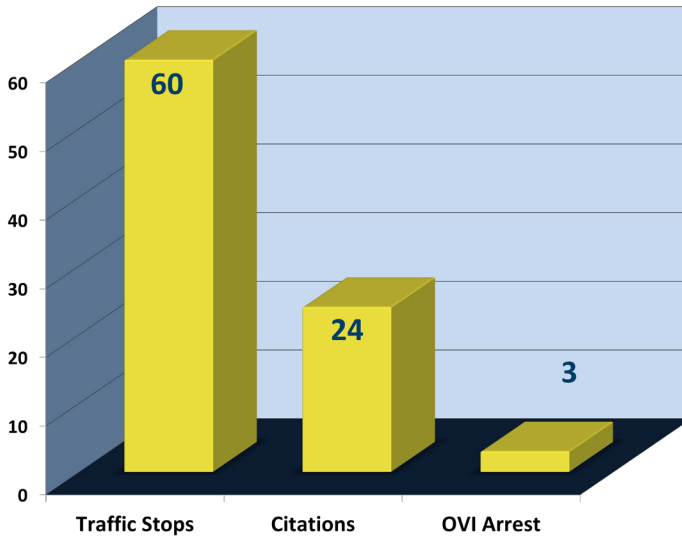

Upon arrival, officers located the offending vehicle and spoke to the female motorist. Upon investigation, the female motorist was charged with Operating a Vehicle Under the Influence of Alcohol or Drugs.

On July 28, 2024, Corporal Knobbe was responded to the 9300 block of Remington Hill for a report of a stolen vehicle. The complainant advised that when he got up for work that morning, his vehicle was gone. Upon investigation, the vehicle was located by the Montgomery County Sheriff's Office on August 2, 2024. The vehicle was returned to the owner.

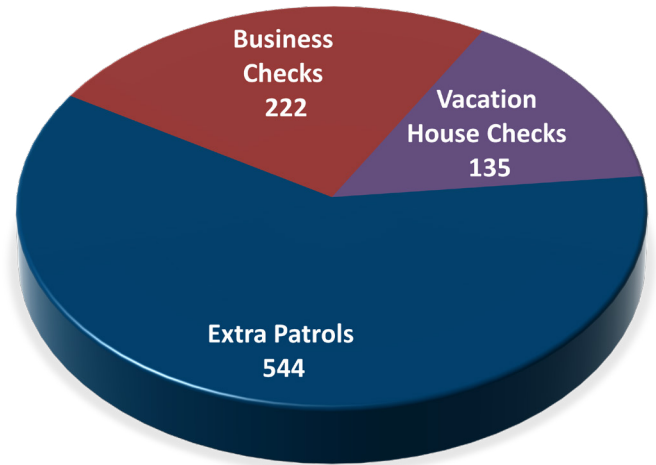

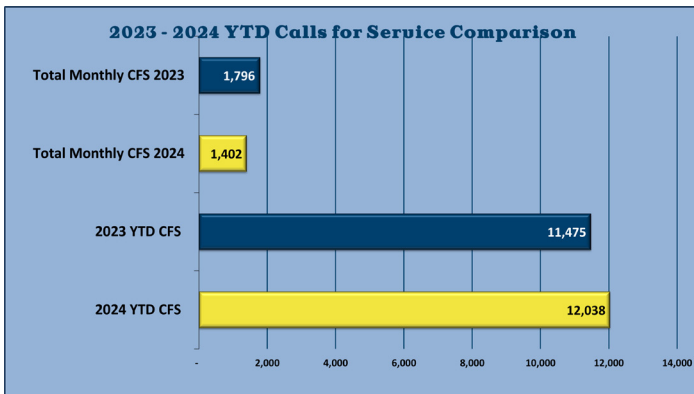

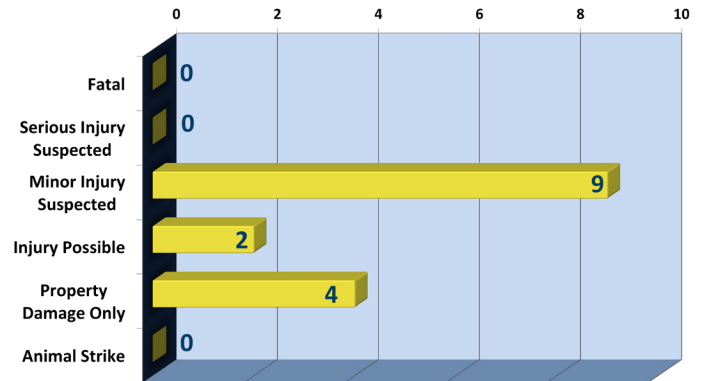

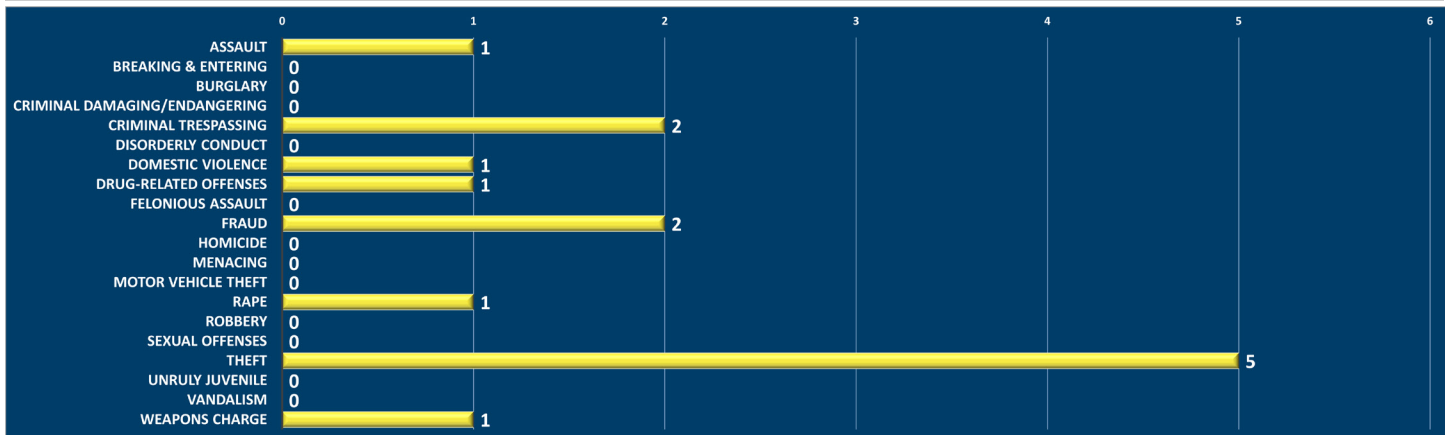
Calls for Service 2023 - 2024 YTD Comparison
