Significant Activity

On August 22, 2024, Sergeant Cordero and Officer Schrage responded to the area of Bunnell Hill Road and East State Route 73 for a report of a one-car motor vehicle accident. When officers arrived on the scene the vehicle was on its top and the motorist needed assistance from the officers to exit the vehicle. The male driver was not injured. Upon investigation, officers detected the smell of an alcoholic beverage coming from the motorist. The motorist refused to perform field sobriety tests or submit a breath sample and was charged with OVI and Failure to maintain control of his vehicle.

On August 18, 2024, Sergeant Sweet responded to Game Day Bar and Grill, located at 7576 North State Route 48, for a report of one patron assaulting another. Upon investigation, a male was arrested for Assault.

On August 17, 2024, Corporal Knobbe and Officer Bronnenberg responded to the 8600 block of North State Route 48 for a report of a two-car motor vehicle accident. Clearcreek Medics responded to the scene and assessed both drivers. One of the involved motorists advised that he had been consuming alcohol that evening and submitted to field sobriety tests. Upon further investigation, the male motorist was charge with OVI and Failure to maintain control of his vehicle.

On August 16, 2024, Officer Bronnenberg responded to a residence in the 3000 block of Crestview Avenue for a report of an active Domestic Dispute. On arrival, officers were advised that a female had assaulted two family members at the residence. Upon investigation, a female was charged with Domestic Violence.

Prior to the officers' arrival, dispatch advised officers they had made contact at the residence and that a Domestic Dispute was in progress. Upon arrival, officers met with a female that stated she was assaulted by a male that was at the residence and that the male had fled. Officer Schrage located the male in a field close to the residence. Upon further investigation, the male was charged with Domestic Violence.



Officers detected the smell of an alcoholic beverage and bloodshot eyes on the motorist. The motorist submitted to field sobriety tests, and upon further investigation, was charged with OVI, Driving under OVI suspension, and open container in a Motor Vehicle. The motorist submitted to a breath test, with the result of 0.293.

On August 4, 2024, Corporal Morgan and Officer Robinson responded to the 2300 block of Presley Court for a report of a Domestic Dispute. A female at the residence told officers that another male resident had pushed her against a wall. Upon investigation, the male was charged with Domestic Violence.




