
Congratulations to Firefighter James Whitney on achieving the best time during the January PPE donning compentency with a time of 1 minute, 12 seconds. Nice job, James!


Alarms by Service Type



Average Response Time



Significant Responses

On 1/1/25 at 05:01 hours, crews responded to a residence for a reported gunshot wound. Upon arrival, crews found a patient with a penetrating wound to the abdomen. Crews initiated ALS procedures and transported the patient to Atrium Medical Center.

On 1/2/25 at 15:45 hours, crews responded mutual aid into Franklin for a reported building fire. Upon arrival, crews found a working fire with Franklin and Middletown crews performing attack. Rescue 21 crews staged as the Rapid Intervention Team while Battalion 21 assisted command. All units remained on scene until released by command after the fire was extinguished.

On 1/3/25 at 17:08 hours, crews responded to a residence for a reported cardiac arrest. Upon arrival, crews found a patient in cardiac arrest with a bystander performing CPR. Crews initiated ALS procedures and transported the patient to Atrium Medical Center. On 1/5/24 at 10:42 hours, crews responded to a nursing home for a reported cardiac arrest. Upon arrival, crews found a patient in cardiac arrest. Crews initiated ALS procedures until presented with a valid DNR from facility staff. Crews ceased care efforts in accordance with Greater Miami Valley EMS Council protocol for DNR. Crews contacted the coroner and released the scene to Springboro PD.

On 1/5/25 at 18:56 hours, crews responded to a residence for a reported cardiac arrest. Upon arrival, crews determined the patient was DOA. Crews contacted the coroner and released the scene to Clearcreek PD.

On 1/6/25 at 06:05 hours, crews responded to a residence for a reported cardiac arrest. Upon arrival crews determined the patient was DOA. Crews contacted the coroner and released the scene to Springboro PD.

On 1/4/25 at 03:28 hours, crews responded to a residence for a reported building fire. Upon arrival, crews found a working structure fire. Further investigation revealed a propane cylinder on the side of the building . Ladder 21 crews were positioned for aerial operations while additional crews provided suppression, salvage, and overhaul. Crews contacted Duke Energy to secure utilities. Lebanon, Franklin, Turtlecreek Township, and Washington Township provided mutual aid assistance. The estimated property damage due to fire is \$250,000.






On 1/8/25 at 08:49 hours, crews responded to South Main Street for a reported vehicle accident with injuries. Upon arrival, crews found two cars involved in a crash. Crews controlled traffic and protected the scene while stabilizing the vehicles. Investigation showed fluid on the roadway and one occupant with minor injuries, who they transported to Atrium Medical Center. Crews mitigated roadway hazards, contacted a towing company, and released the site to Springboro PD.




On 1/13/25 at 00:54 hours, crews responded to a residence for a reported building fire. Upon arrival, crews found a residential structure with working fire. Engine 23 crews stretched a handline for fire attack. Crews found extension into the walls and attic and pulled a secondary line to assist with suppression. Once the fire was extinguished, crews checked for heat signatures and performed overhaul. Franklin Township provided mutual aid assistance. The estimated property damage due to the fire is \$10,000.



On 1/13/25 at 06:14 hours, crews returned to the residence of an earlier incident for a reported building fire. Upon arrival, crews confirmed a working fire in the garage and roof of a residential structure. Crews used two handlines and foam to extinguish the fire. Crews checked for extension and extinguished fire in the attic space. Once the fire was extinguished, crews extinguished hot spots throughout the residence. Lebanon, Turtlecreek Township, and Wayne Township provided mutual aid assistance. The estimated property damage due to the fire is \$273,000.






On 1/13/25 at 09:37 hours, crews responded to Clearcreek Franklin Road for a reported motor vehicle accident with injuries. Upon arrival, crews found two vehicles involved in a crash. Crews controlled traffic and protected the scene while stabilizing the vehicles. Investigation showed fluid on the roadway. Medic 21 transported one patient to Atrium Medical Center and Medic 22 transported another to Kettering Health Franklin. Crews mitigated roadway hazards, contacted a towing company, and released the site to Springboro PD. On 1/14/25 at 14:14 hours, crews responded mutual aid into Washington Township for a reported building fire. Upon arrival, crews found a residential building with active fire. Crews staged for workforce assistance until released by command.

On 1/17/24 at 16:21 hours, crews responded to mutual aid into Wayne Township for a reported cardiac arrest. Upon arrival, crews found a patient in cardiac arrest with CPR in progress. Crews initiated ALS procedures with no response from the patient. Medical Control provided a field termination of resuscitation efforts order. Crews contacted the coroner and released the scene to Wayne Township.

On 1/20/24 at 17:26 hours, crews responded to a residence for a reported cardiac arrest. Upon arrival, crews found a patient with an injury from a fall. During transport, the patient went into cardiac arrest. Crews initiated ALS procedures and transported the patient to Atrium Medical Center.

On 1/22/25 at 14:25 hours, crews responded to a business for reported chest pains. Upon arrival, crews found a patient complaining of chest pains. During transport, the patient became unresponsive. Crews initiated ALS procedures and transported the patient to Kettering Health Main Campus.
