Approximately 2,000 township residents and guests attended even though we experienced heavy rain earlier in the day. Families walked the grounds of Patricia Allyn Park together as they visited various display booths and demonstrations put on by the Police Division, the Fire District and our area partners; including the Ohio State Highway Patrol, the Warren County Sheriff's Office, the Warren County Prosecutor's Office and many other agencies that provide services to Warren County. Guests enjoyed the opportunity to meet and mingle with officers, and enjoy a hamburger or hot dog. The children enjoyed the numerous activities and safety stations that included a bike rodeo, our seat belt safety train, a child identification booth and our "Safety Town Village". The event was again coordinated by Officer Nicole Cordero under the direct supervision of Chief John Terrill. Officer Cordero has been planning this event for several years now and her efforts are greatly appreciated. There were many positive comments from participants and visitors. 





1st Shift— 31 2nd Shift— 124 3rd Shift— 86






In August 2018 Clearcreek Township went through its second annual CALEA compliance check. CALEA Compliance Services Member Marc Duguay remotely reviewed 80 standards for the agency using The Law Enforcement Manual . These standards included specific time-sensitive issues, as well as all standards applicable to the agency by size and function. After reviewing the required standards, the compliance specialist found that all proof files were in order and proved continued compliance with the standards reviewed. 


CALLS OVER THE PAST 10 YEARS


Domestic Violence Statistics

2018 Victims: 13% Male, 87% Female 2018 Offenders: 87% Male, 13% Female


2017 Victims: 30% Male, 70% Female 2017 Offenders: 90% Male, 10% Female




2018 Crime Reporting Statistics




2017 Crime Reporting Statistics




2016 Crime Reporting Statistics





Internal Affairs 2018

To insure the integrity of its operations and personnel, the Clearcreek Township Division of Police investigates all allegations of police misconduct, regardless of their source. The Chief of Police is responsible for the Internal Affairs function of the agency. Investigations may be initiated by a citizen complaint or internally, by a supervisor or on the complaint of a fellow employee. Citizen complaint forms are available at the police department or by contacting a police supervisor.

In calendar year 2018 there were no (0) Internal Affairs investigation that originated from an internal complaint, and no (0) investigations originating from citizen complaints. Police Department—Personnel Training
