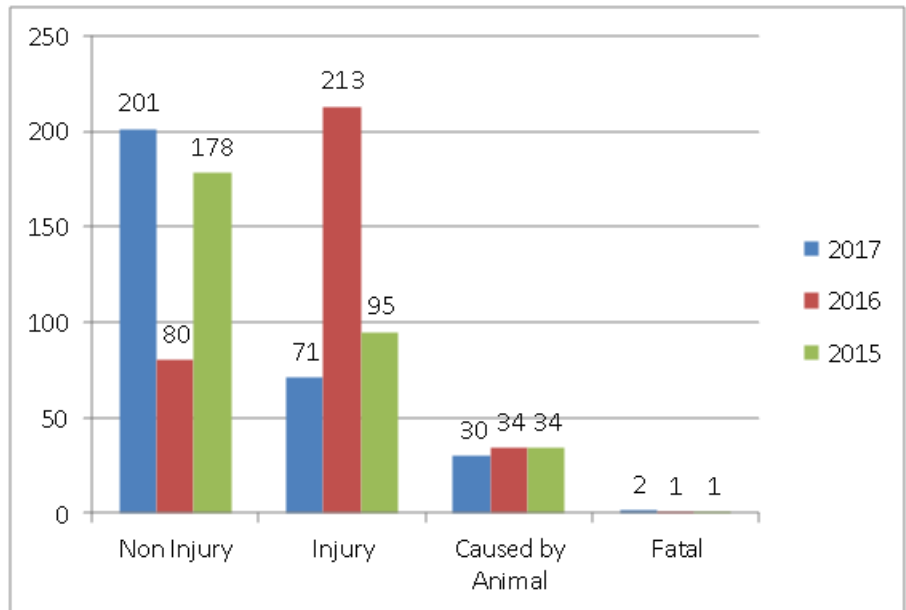
7th Annual Polar Plunge at Caesar Creek

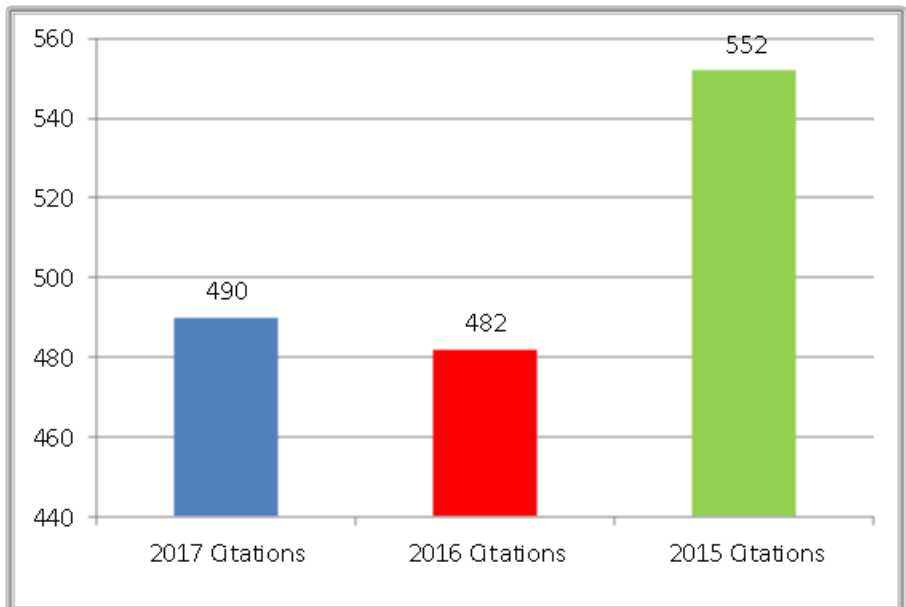
Crash Statistics

 2015 = 307



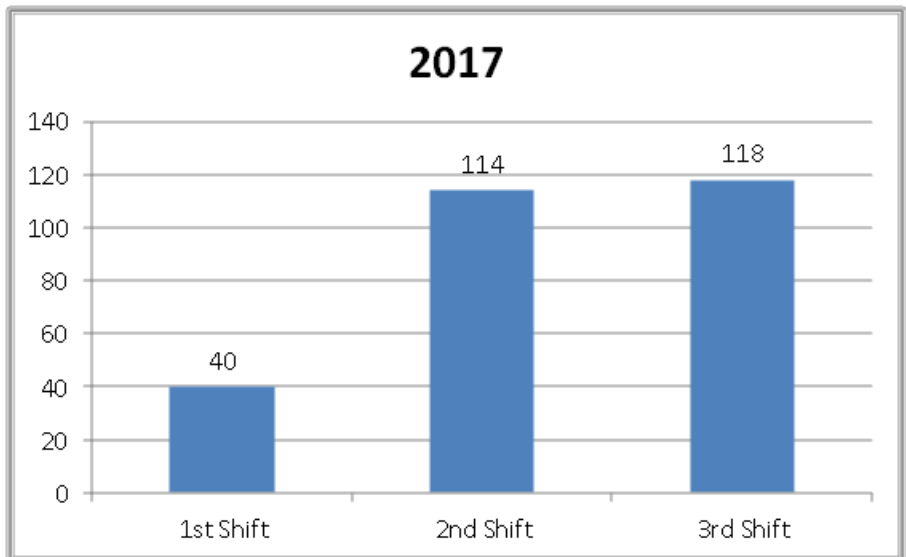
Citations

 3rd Shift— 118



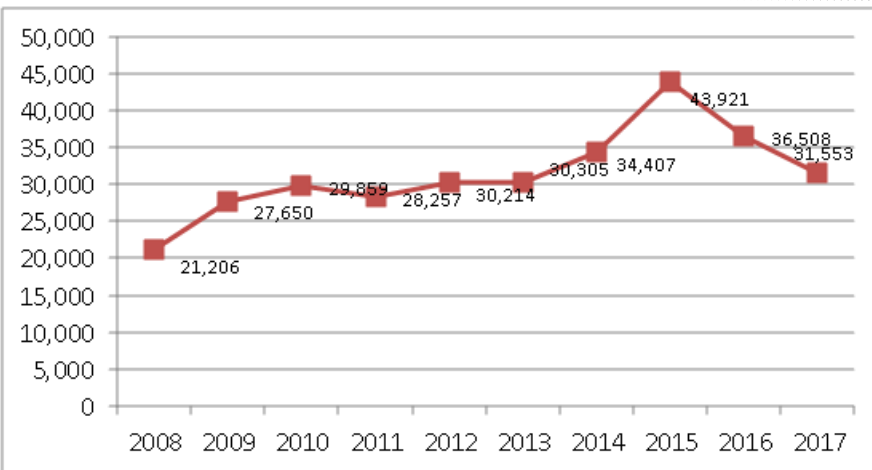

Accreditation Update

2017 was a year of change in the Clearcreek Township Police Department’s efforts to maintain its accredited status with the Commission on Accreditation for Law Enforcement Agencies (CALEA). CALEA has undergone several changes to its process in the last few years. Instead of a three year accreditation cycle in which the Commission would send two assessors to evaluate the agency on all 484 standards, they have begun doing annual compliance checks of 25% of the standards during the first three years and then a full assessment on the fourth year. The hope is that annual compliance checks will reduce the time the assessors spend looking at compliance files during the on-site and provide more time to get out into the community, ride-along with officers, and interview community leaders and others who work closely with the department to see that they are complying with their own policies and the intent of the CALEA standards. In August 2017 Clearcreek Township went through its first annual compliance check. After reviewing the required standards, the compliance specialist found that all proof files were in order and proved compliance with the standards reviewed.

2017 was also the first year that the Ohio Collaborative Community-Police Advisory Board began to certify law enforcement agencies around the State. In April 2017 the Clearcreek Township Police filed its proofs of compliance with the Collaborative standards and received State Certification.

State Certification through the Collaborative and international accreditation through CALEA are evidence of the township’s commitment to providing professional policing, that exceeds industry standards, to the citizens who live and work in Clearcreek Township.

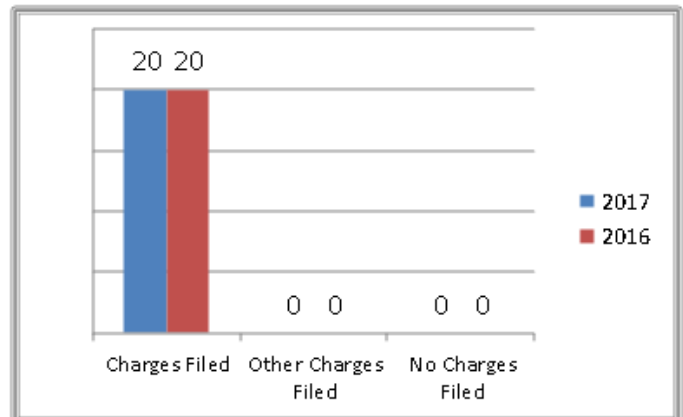

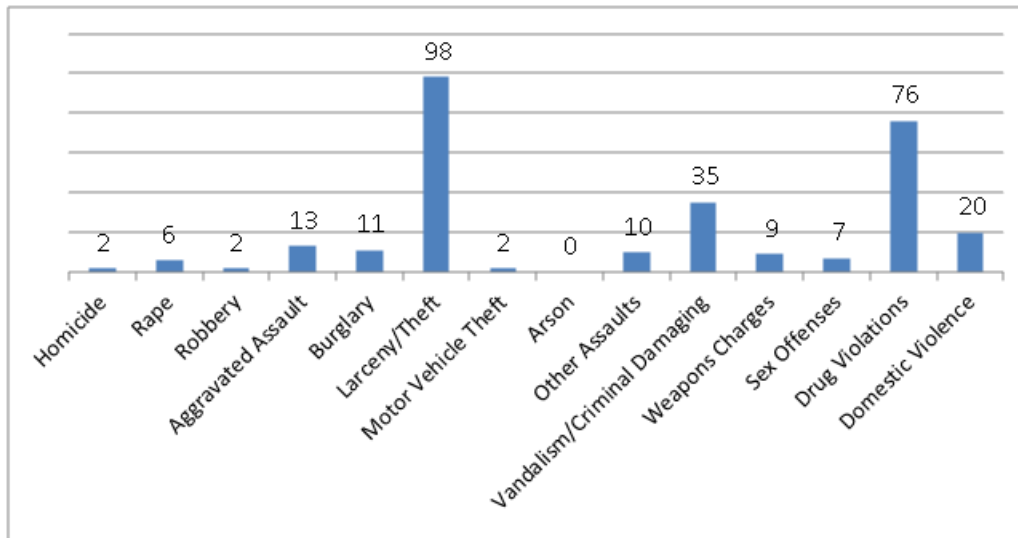
Domestic Violence Statistics

 2017 Offenders: 90% Male, 10% Female

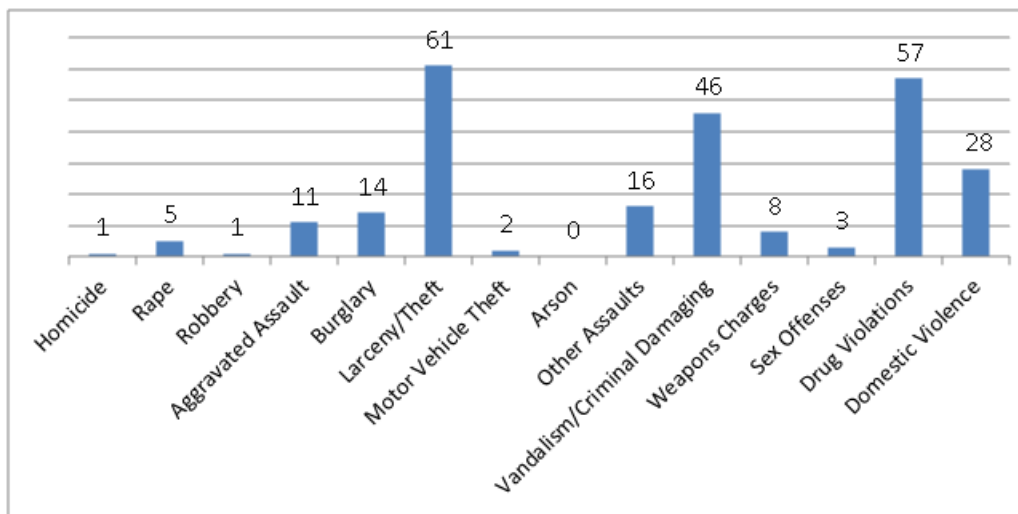
2016 Victims: 32% Male, 68% Female
 2016 Offenders: 82% Male, 18% Female



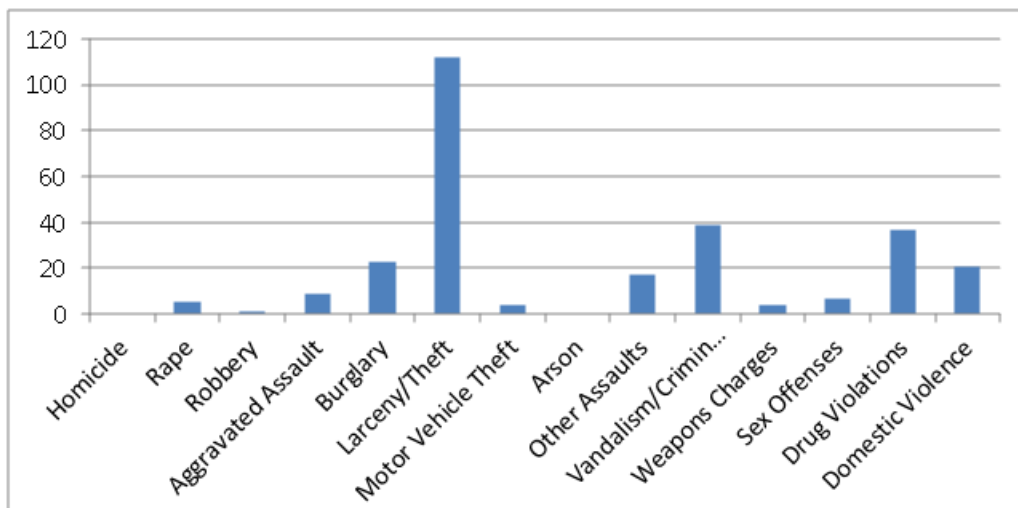
2017 Crime Reporting Statistics



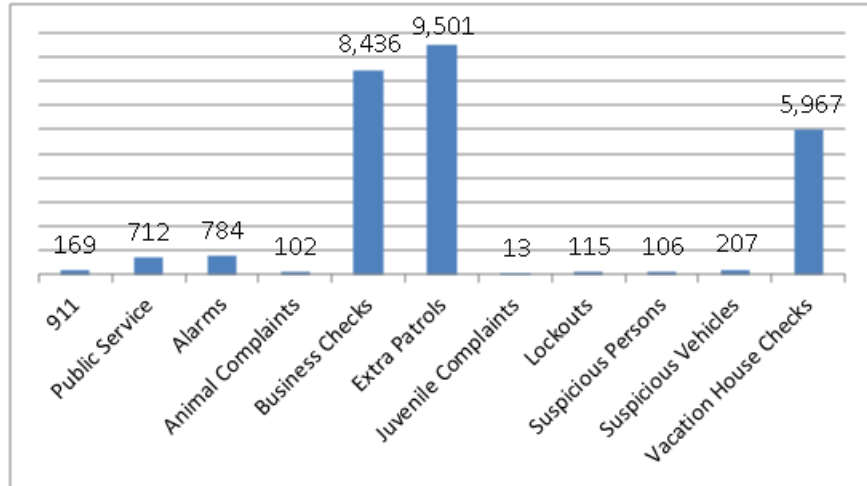
2016 Crime Reporting Statistics



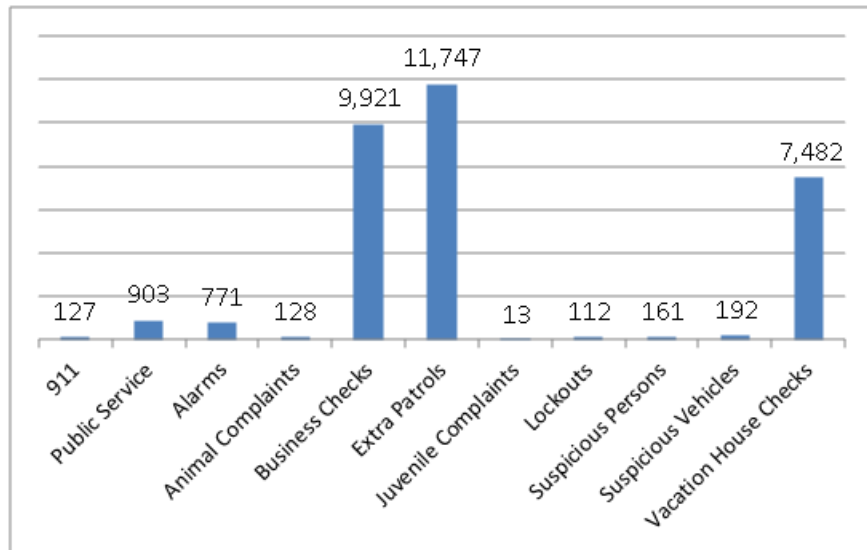
2015 Crime Reporting Statistics



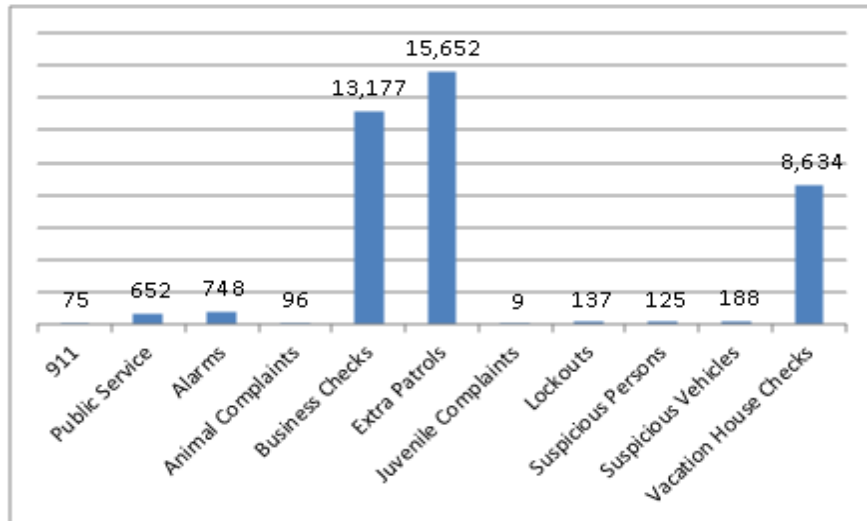

Internal Affairs 2017

To insure the integrity of its operations and personnel, the Clearcreek Township Division of Police investigates all allegations of police misconduct, regardless of their source. The Chief of Police is responsible for the Internal Affairs function of the agency. Investigations may be initiated by a citizen complaint or internally, by a supervisor or on the complaint of a fellow employee. Citizen complaint forms are available at the police department or by contacting a police supervisor.

In calendar year 2017 there were no (0) Internal Affairs investigation that originated from an internal complaint, and no (0) investigations originating from citizen complaints. Police Department—Personnel Training
