Clearcreek Township Division of Police 2016 Annual Report

2016 found Clearcreek Township remaining as not only one of the Safest Communities to live locally, but also in the State and Tri-Stat.

Safwise and Bizjournales rated Clearcreek Township the 11th Safest Community to live in the State of Ohio. When further broken down to assess the category of mid-size cities with populations of 10-20 thousand, Clearcreek Township placed 8th Safest Community in the State of Ohio. Cincy Magazine rated Clearcreek Township as the 3rd Safest Community to live in the Tri-State. This continues Clearcreek Township's run of being in the Top 10 Safest Communities for the 9th year in a row.

We also continued our participation in the FOP countywide program, Shop with a Cop, benefiting families at Christmas Time by providing children with Christmas presents.

2016 was our second year of hosting Children Safety Town. Safety Town is a program where children ages 6-8 attend a 5 day class where they are taught safety issues by Police Officers. Some of the topics covered are: pedestrian safety, traffic signals, using 911, internet safety, stranger danger, school bus safety, fire safety, etc. The children are taught in a classroom and in a hands-on setting in a scaled down village. 238 children attended the program in 2016. This program is staffed by Officers of Clearcreek Township and Springboro Police Department. Members of the Clearcreek Township Fire Department and Springboro School System also assist in training components of the program.

Officer Cordero has been planning this event for several years now and her efforts are greatly appreciated. There were many positive comments from participants and visitors. 


Crash Statistics





1st Shift— 28 2nd Shift— 157 3rd Shift— 115






Clearcreek Township Police Awarded Re-Accreditation

In July 2010 the Clearcreek Township Police Department was awarded its initial accreditation by the Commission on Accreditation for Law Enforcement Agencies (CALEA). Accreditation lasts for a three year period. In July 2013, we received our first Re-Accreditation. In between on-site assessments, the agency must maintain compliance with CALEA standards and file an annual report with CALEA attesting to continued compliance.

In July of 2016 CALEA sent two assessors to evaluate our standing for a second re-accreditation. Sgt. Stacy, with assistance from Officer Bates, assembled proof files for the 481 standards on which the police department was evaluated. The on-site assessment was our best to date and in the assessors report to the commission, they recommended us for re-accreditation. Sgt. Stacy expressed his thanks to the Police Department staff, as well as Township Administration, the Trustees, and the Fiscal Officer for their assistance in making the on-site such a success.

Because of the successful on-site, we were invited to attend the CALEA conference in November 2016. On Saturday November 5th Chief Terrill, Sgt. Stacy and Officer Bates appeared before a committee of CALEA commissioners, who took turns asking questions about our agency, its successes, and the on-site assessment. At the end of that hearing the commissioners voted to recommend us to the entire commission for a vote on re-accreditation. When the entire commission met that afternoon, they voted to bestow that honor upon our Police Department and that evening, at the "Celebration Banquet", the Clearcreek Township Division of Police were presented their second re-accreditation by CALEA Commission Chairman Richard Myers and Executive Director Craig Hartley.

CALEA accreditation represents Chief Terrill's commitment to professional excellence as the CALEA standards require that we adhere to accepted best practices in law enforcement policy and practice. The following statistics provided by the Bureau of Justice Statistics and CALEA are particularly noteworthy. There are just over 20,000 law enforcement agencies in the United States. Of these agencies 1018 are accredited (5%). Of those accredited agencies, 48 (.2%) are small "A" sized agencies such as ourselves. In the State of Ohio there are 65 accredited agencies, of which only 7 are "A" sized. This commitment to professional excellence shows in the way our officers interact with and serve our citizens every day.




CALLS OVER THE PAST 10 YEARS


Domestic Violence Statistics

2016 Victims: 32% Male, 68% Female 2016 Offenders: 82% Male, 18% Female


2015 Victims: 37% Male, 63% Female 2015 Offenders: 75% Male, 25% Female




2016 Crime Reporting Statistics




2015 Crime Reporting Statistics




2014 Crime Reporting Statistics




2016 Summary of Calls



Internal Affairs Summary for 2016

To insure the integrity of its operations and personnel, the Clearcreek Township Division of Police investigates all allegations of police misconduct, regardless of their source. The Chief of Police is responsible for the Internal Affairs function of the agency. Investigations may be initiated by a citizen complaint or internally, by a supervisor or on the complaint of a fellow employee. Citizen complaint forms are available at the police department or by contacting a police supervisor.

In calendar year 2016 there were no (0) Internal Affairs investigation that originated from an internal complaint, and no (0) investigations originating from citizen complaints.
