### Honoring Assistant Chief Tim Simpson



Tim Simpson joined the Clearcreek family in 1986 as a Volunteer Firefighter/EMT. At that time, we operated as two separate entities, the Clearcreek Township Volunteer Fire Company and the Clearcreek Township Volunteer Life Squad. In 1988, the Fire Company and Life Squad combined to

become the Clearcreek Fire District which is the same year Tim earned his Paramedic certification.

Throughout his career, Tim has proved his loyalty to the District and his continued willingness to go above and beyond on many occasions. These attributes allowed him to advance through the ranks, being promoted to Lieutenant in 1991, and Captain in 1993. At this time, we had one station, a full-time Chief, two full-time Captains, and a staff of part-time personnel who all lived in the community. In December 2001, Tim was promoted to the rank of Chief Officer and now retires as the Assistant Chief of Administration.

During his career, Tim helped steer the organization through some good times and some tough times. His understanding of technology has proven critical to moving our organization forward. Being detail-oriented is a trait he is known for and proud of. Because of this, Chief Simpson was able to earn the Fire District \$3,689,420.74 in grant awards during his tenure!

Because of his incredible memory, Tim often serves, not only as an advisor, but also as the department historian. As a lifelong resident of Springboro, Tim and his wife Janis raised both of their children, Sara and Geoffrey, here. In addition to his work with the Fire District, Tim truly loves the community in which he both lives and serves.



On December 16, 2022, after 36-years of service to Clearcreek Township and the City of Springboro, Assistant Chief Tim Simpson begins his retirement. It is hard to imagine our family without him guiding us. But, thanks to his dedication and mentoring, we will all carry something of Tim with us into the future; and for that, we are beyond grateful. We all wish Tim the very best as he begins this new chapter.

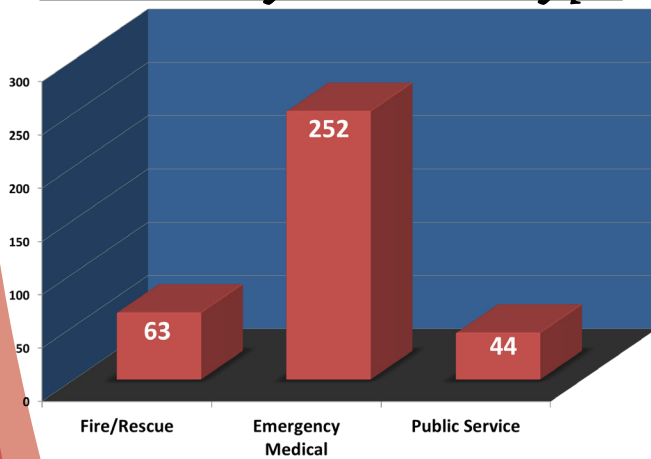

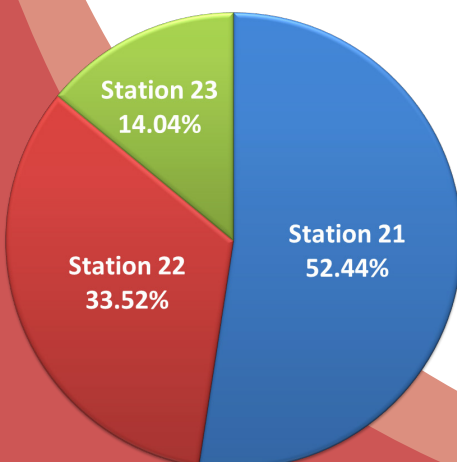
## Alarms by Service Type

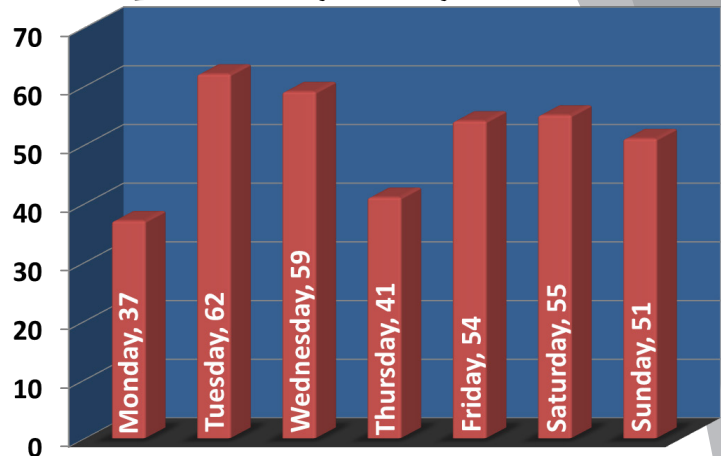
## Response Percentages

# SIGNIFICANT RESPONSES

On 11/1/22 @ 18:05 hours, crews responded to Reed Road for a reported building fire. Upon arrival, crews found a two-story residential structure with smoke showing from the front. Further investigation revealed a fire in a second-floor room. Using a handline, crews extinguished the fire and checked for extension. Finding no additional fire, crews performed ventilation. No occupants reported injury from the incident. Washington Township provided mutual aid assistance. The estimated property damage from fire is \$5,500.

On 11/3/22 @ 21:48 hours, crews responded to Sharts Road for a reported outside equipment fire. Upon arrival, crews found fire and smoke showing from a dust collector at a commercial structure. All occupants evacuated the building with no reported injuries. Further investigation revealed smoke inside the building. Crews extinguished the fire using a handline and checked for extension inside the building. Finding no extension into the building, crews performed ventilation. Miami Valley Fire District provided mutual aid assistance. The estimated property damage from fire is \$10,000.



On 11/7/22 @ 09:34 hours, crews responded to a nursing home for a reported cardiac arrest. Upon arrival, crews found a patient in cardiac arrest, with facility staff performing CPR. Crews initiated ALS protocol with no response from the patient. Medical control provided a field termination of resuscitation efforts order. Crews contacted the coroner and released the scene to Clearcreek PD.

On 11/10/22 @ 06:39 hours, crews responded to a nursing home for a reported unconscious/unresponsive person. Upon arrival, crews determined the patient was DOA. Crews contacted the coroner and released the scene to Springboro PD.

On 11/18/22 @ 22:06 hours, crews responded to Paw Paw Drive for a reported building fire. Upon arrival, crews found a residential building with smoke showing from the roof. Further investigation showed a fire in the attic involving several structural members of the house. Rescue crews removed parts of the ceiling to extinguish the fire in the attic and moved smoldering debris into the yard for extinguishing. Crews checked for extension and, finding no additional hazards, secured the building. The estimated property damage from fire is \$15,000.

On 11/19/22 @ 14:19 hours, crews responded to a residence for a reported unknown illness. Upon arrival, crews determined the patient was DOA. Crews contacted the coroner and released the scene to Clearcreek PD.

On 11/22/22 @ 14:48 hours, crews responded to a mutual aid call into Wayne Township for a reported vehicle accident with injuries. Upon arrival, crews found a semi-trailer and a tractor involved in a crash with one person entrapped. Crews determined one patient was DOA. Ohio State Patrol and Wayne Township Fire Department stopped traffic and shielded the scene. Additional crews from Wayne Township stabilized the semi-truck while Clearcreek crews extricated the entrapped patient. Crews initiated ALS procedures and transferred patient care to CareFlight. After clearing the site of hazards, crews released the scene to Ohio State Patrol.

On 11/24/22 @ 00:10 hours, crews responded to a nursing home for a reported non-breather. Upon arrival, crews found a patient in cardiac arrest with staff performing CPR. Crews initiated ALS procedures with no response from the patient. Medical Control provided a field termination of resuscitation efforts order. Crews contacted the coroner and released the scene to Springboro PD.

On 11/24/22 @ 17:30 hours, crews responded to a residence for a reported unconscious/unresponsive person. Upon arrival, crews found a patient in cardiac arrest with a bystander performing CPR. Crews initiated ALS procedures with no response from the patient. Medical Control provided a field termination of resuscitation efforts order. Crews contacted the coroner and released the scene to Clearcreek PD.

On 11/26/22 @ 04:24 hours, crews responded to State Route 42 for a reported vehicle accident with injury. Upon arrival, crews found a single car on its side, off-road, with one occupant entrapped. Crews extricated the driver and transported one patient to Atrium Medical Center. Additionally, crews secured the site of hazards and released the scene to Clearcreek PD.

On 11/29/22 @ 10:05 hours, crews responded to a residence for a reported non-breather. Upon arrival, crews found a patient in cardiac arrest with family performing CPR. Crews initiated ALS procedures with no response from the patient. Medical Control provided a field termination of resuscitation efforts order. Crews contacted the coroner and released the scene to Clearcreek PD.
