Station 24 Updates

In December, plumbing crews completed gas service installation and equipment hook-up. 




Total Alarms


Alarms by Service Type

Response Percentages



Significant Responses

On 12/4/24 at 19:43 hours, crews responded to Cambridge drive for a reported passenger vehicle fire. Upon arrival, crews found a car fully involved in flames. Crews deployed a handline and extinguished the fire using both water and foam suppressant. Once extinguished, crews cleared the site of hazards and released the scene to Springboro PD. The estimated property damage due to fire is \$5,688.



On 12/5/24 at 17:07 hours, crews responded to a residence for a reported cardiac arrest. Upon arrival, crews found a patient in cardiac arrest. Crews initiated ALS procedures and transported the patient to Atrium Medical Center.

On 12/6/24 at 08:50 hours, crews responded to a residence for a reported cardiac arrest. Upon arrival, crews determined the patient was DOA. Crews contacted the coroner and released the scene to Springboro PD.

On 12/7/24 at 11:29 hours, crews responded to a residence for a reported cardiac arrest. Upon arrival, crews determined the patient was DOA. Crews contacted the coroner and released the scene to Springboro PD.

On 12/8/24 at 01:44 hours, crews responded mutual aid into Wayne Township for a reported cardiac arrest at a nursing home. Upon arrival, crews found a patient in cardiac arrest with staff performing CPR. Crews initiated ALS procedures and transported the patient to Miami Valley Hospital South.

On 12/11/24 at 00:32 hours, crews responded to a business for a reported cardiac arrest. Upon arrival, crews determined the patient was DOA. Crews contacted the coroner and released the scene to Springboro PD.

On 12/16/24 at 11:28 hours, crews responded to a residence for reported breathing problems. Upon arrival, crews found a patient in respiratory distress with a valid DNR. The patient went into cardiac arrest shortly after arrival. Crews followed Greater Miami Valley EMS Council protocol for DNR and remained on the scene while Springboro PD completed their investigation.

On 12/21/24 at 11:45 hours, crews responded to a residence for a reported cardiac arrest. Upon arrival, crews determined the patient was DOA. Crews contacted the coroner and released the scene to Clearcreek PD.

On 12/24/24 at 14:39 hours, crews responded to a church for a reported cardiac arrest. Upon arrival, crews found a patient in cardiac arrest with a bystander performing CPR. Crews initiated ALS procedures and transported the patient to Kettering Health Main Campus.

On 12/29/24 at 04:30 hours, crews responded to a residence for a reported cardiac arrest. Upon arrival, crews found a patient in cardiac arrest. Crews initiated ALS procedures and transported the patient to Atrium Medical Center.



Fire and Rescue Training

Crews completed Fire Core Competency-Based training on Blue Card Incident Command scenarios.

Unit 3 completed the Hose Marathon. This task, which they completed throughout 97 shifts, aims to pull 26.2 miles of hose or 134,400 feet. The crew accomplished the challenge in 692 pulls of 200-foot hose loads, averaging 1,430 feet pulled per shift.
