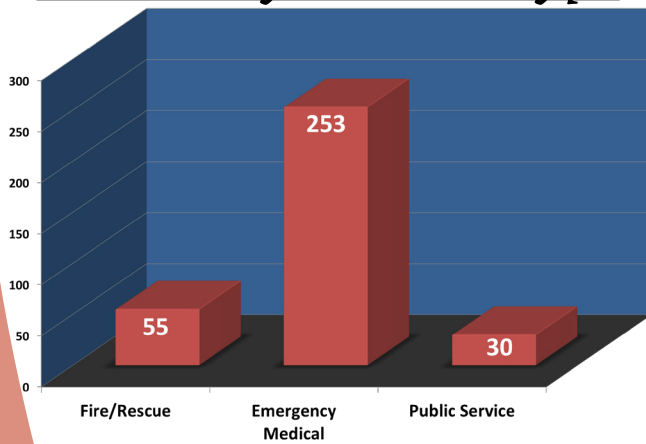




Total Alarms

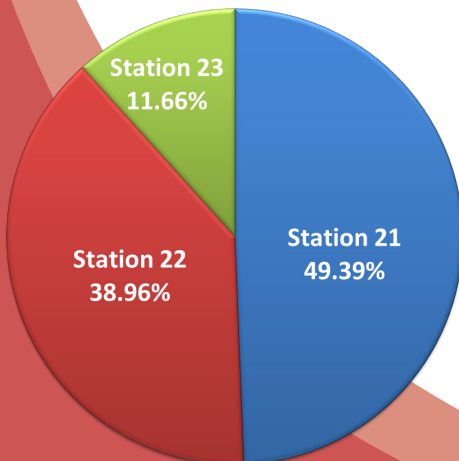
Alarms by Service Type

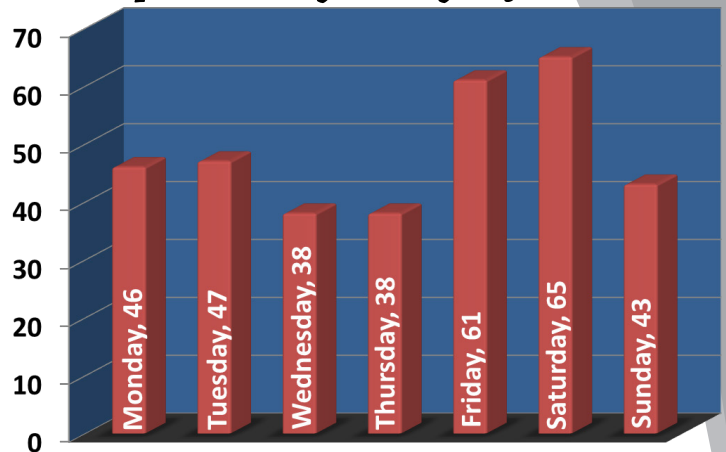
Response Percentages

SIGNIFICANT RESPONSES

On 4/3/22 @ 19:20 hours, crews responded for a reported bicycle accident. Upon arrival, crews found a patient on the ground. Medics initiated ALS procedures and transported the patient to Children's Dayton.

On 4/7/22 @ 23:25 hours, crews responded to a mutual aid for a reported vehicle accident with injuries. While en route, Warren County Dispatch advised responders of a vehicle into a fire engine with two entrapments. Upon arrival, crews found one car showing damage to the front end and a City of Franklin engine showing rear end damage. Crews assisted in the extrication of one patient who was DOA. Crews remained on the scene at the request of the Ohio State Patrol to provide protection duties.



On 4/8/22 @ 19:41 hours, crews responded mutual aid to Wayne Township for a reported vehicle accident with injuries. Upon arrival, crews found a crash involving two vehicles. Crews shielded the scene and extricated one patient. After stabilizing the vehicles and securing the roadway of hazards, crews released the scene to Ohio State Patrol.

On 4/10/22 @ 12:40 hours, crews responded to State Route 73 and Township Line Road for a reported vehicle accident with injuries. Upon arrival, crews found a crash involving two vehicles. Engine crews shielded the site and stabilized the vehicles. Medic crews transported one patient to Miami Valley Hospital South and another patient to Bethesda Medical Center.



On 4/13/22 @ 07:11 hours, crews responded to a residence for a reported unconscious/unresponsive person. Upon arrival, crews found a patient in cardiac arrest. Crews initiated ALS procedures with no response from the patient. Medical control provided a field termination of resuscitation efforts order.

On 4/22/22 @ 07:46 hours, crews responded to a nursing home for a reported non-breather. Upon arrival, crews found a patient DOA. Crews contacted the coroner and released the scene to Springboro PD.



On 4/13/22 @ 13:22 hours, crews responded to Wright Station Way for a reported vehicle fire. Upon arrival, crews found a pick-up truck with fire in the engine compartment. Crews extinguished the fire using a handline and then disconnected the battery. Finding no additional hazards, crews released the scene to Springboro PD. The estimated property damage from fire is \$80,000.

On 4/22/22 At 23:54 hours, crews responded to Oak Brook Drive for a reported building fire. Upon arrival, crews found light smoke in the building with all occupants evacuated. Further investigation revealed a gas oven that caught fire during cleaning. The homeowner used a dry chemical extinguisher on the oven prior to crew arrival but was unable to extinguish the fire. Crews shut off the gas line, removed the stove from the house, and extinguished the remaining fire inside the oven. Crews performed ventilation and checked for extension. The estimated property loss due to fire is \$2,000.



On 4/17/22 @ 16:02 hours, crews responded to a residence for a reported cardiac arrest. Upon arrival, medics found a patient DOA. Crews contacted the coroner and released the scene to Springboro PD.

On 4/21/22 @ 03:25 hours, crews responded to a residence for a reported non-breather. Upon arrival, medics found a patient unresponsive. Crews initiated ALS procedures and transported the patient to Children's Dayton South.

On 4/25/22 @ 01:36 hours, crews responded to a nursing home for a reported fall. Upon arrival, medics found a patient unresponsive, who fell in front of the entry door, blocking access. Rescue crews gained entry through a window. Upon assessment, medic crews initiated ALS procedures and transported the patient to Atrium Medical Center with a stroke alert. Rescue crews released the scene to building maintenance to secure the entry window.
