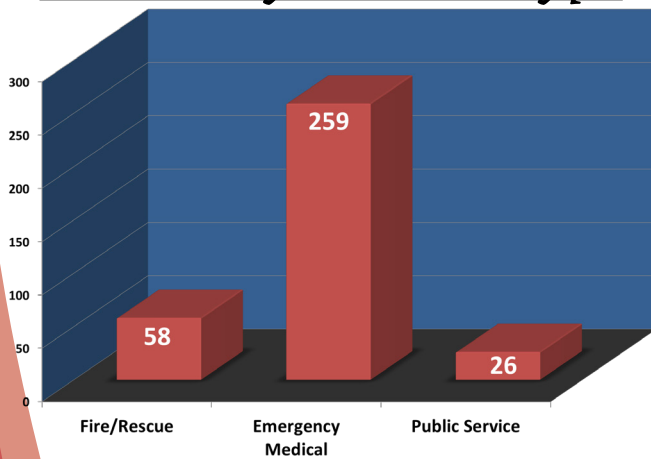




Total Alarms

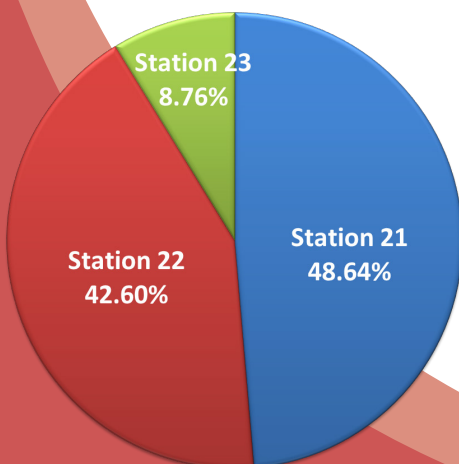
Alarms by Service Type

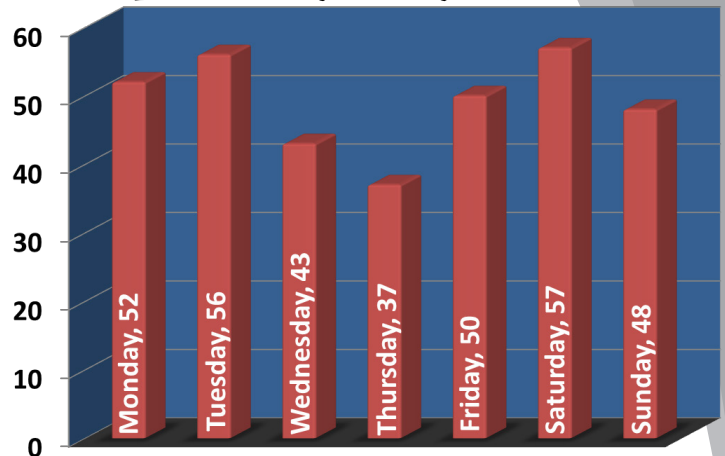
Response Percentages

SIGNIFICANT RESPONSES

On 7/1/22 @ 07:28 hours, crews responded to Jeanne Drive for a reported vehicle accident with injuries. Upon arrival, crews found a truck crashed into a residence with light smoke showing from the building's garage. Further investigation showed the truck struck a gas meter, causing a gas leak. Crews found no gas leaking into the home and determined the smoke originated from the truck tires. Medic 21 crews transported one person to Kettering Health Main Campus. Rescue 21 crews contacted Duke Energy to shut off the gas, performed ventilation, and secured the structure after a tow company removed the truck.



On 7/9/22 @ 15:34 hours, crews responded to State Route 48 for a reported vehicle accident with injuries. Upon arrival, crews found a car crashed into a building. Vehicle occupants evacuated the car and reported no injuries. Crews stabilized the car and checked inside the building for injuries and structural damage. No persons inside the building reported injuries. Investigation showed damage to a window frame but no structural compromise. Crews contacted the Warren County Building Department and a towing company to remove the vehicle.



On 7/4/22 @ 02:29 hours, crews responded to a nursing home for a reported non-breather. Upon arrival, crews found a patient in cardiac arrest with facility staff performing CPR. Crews initiated ALS procedures and transported the patient to Kettering Health Washington Township.

On 7/4/22 @ 21:49 hours, crews responded to Crossley Road for a reported building fire. Upon arrival, crews found heavy smoke and fire showing through the eaves and the roof. All occupants evacuated the building but reported two dogs trapped inside. A Primary search resulted in finding both dogs inside the structure. Using handlines, crews attacked the fire from both the exterior and interior. After extinguishing the main body of the fire, crews extinguished hotspots and checked for extension. Crews performed a secondary search to locate and extinguish hotspots. Washington Township, Wayne Township, the City of Franklin, and Turtlecreek Township provided mutual aid assistance. The estimated property damage from fire is \$125,000. On 7/5/22 @ 10:10 hours, crews returned to the residence for a reported building fire. Upon arrival, crews found smoke from a smoldering roof section that had rekindled. Crews extinguished the fire, performed overhaul, and extinguished any remaining hotspots. Washington Township provided mutual aid assistance.



On 7/9/22 @ 21:53 hours, crews responded to West Central Avenue for a reported passenger vehicle fire. Upon arrival, crews found a car with fire primarily in the engine area but spreading to the passenger compartment. The driver evacuated the vehicle and reported no injuries. Crews extinguished the fire using a bumper line. The estimated property damage due to fire is \$41,500.



On 7/10/22 @ 19:12 hours, crews responded to a residence for a reported non-breather. Upon arrival, crews determined the patient was DOA. Crews contacted the coroner and released the scene to Springboro PD.

On 7/12/22 @ 16:11 hours, crews responded to Pekin Road for a reported vehicle accident with injuries. Upon arrival, crews found a commercial truck rolled over with hydraulic fluid leaking from various locations. Crews applied absorbent to the affected areas, stabilized the vehicle, and transported one patient to Atrium Medical Center.



On 7/12/22 @ 20:43 hours, crews responded to a residence for a reported gunshot. Upon arrival, crews found one patient with a gunshot wound. Crews initiated ALS procedures and transferred care to CareFlight. Crews determined another patient was DOA. Crews contacted the coroner and released the scene to Clearcreek PD.

On 7/19/22 @ 06:15 hours, crews responded to a nursing home for a reported non-breather. Upon arrival, crews determined the patient was DOA. Crews contacted the coroner and released the scene to Springboro PD.

On 7/19/22 @ 06:54 hours, crews responded to a nursing home for a reported non-breather. Upon arrival, crews found a patient in cardiac arrest with facility staff performing CPR. Crews initiated ALS procedures with no response from the patient. Medical Control provided a field termination of resuscitation efforts order. Crews contacted the coroner and released the scene to Springboro PD.

On 7/20/22 @ 09:18 hours, crews responded to Hart Road for a reported vehicle accident with injuries. Upon arrival, crews found a pickup truck and tractor trailer involved in a crash with the pickup into a ditch and the driver entrapped. Crews extricated the driver and transported one patient to Kettering Health Main Campus. Finding no additional hazards, crews released the scene to Clearcreek PD.

On 7/24/22 @ 10:34 hours, crews responded to West Lower Springboro Road for a reported building fire. Upon arrival, crews noted dry chemical extinguisher powder and a burned electrical odor. Prior to crew arrival, the homeowner found an electric panel on fire and used the extinguisher on the flames. All occupants evacuated the building. Crews transported one patient to Kettering Health Franklin. Investigation showed burned insulation and heat signatures around the electric panel. Crews cut off power to the electrical box and contacted Duke Energy. Turtlecreek Township and Wayne Township provided mutual aid assistance. The estimated damage from fire is \$5,000.

On 7/31/22 @ 08:42 hours, crews responded to a nursing home for a reported non-breather. Upon arrival, crews determined the patient was DOA. Crews contacted the coroner and released the scene to Springboro PD.

On 7/31/22 @ 13:57 hours, crews responded to a residence for a reported lock-out. Upon arrival, crews met with the resident's family who were unable to contact the occupant. Crews gained access into the building and found a patient with stroke symptoms. Crews initiated ALS procedures and transported the patient to Kettering Health Main Campus.
