

SIGNIFICANT RESPONSES

On 7/1/23 @ 23:45 hours, crews responded to Trudy Court for a reported structure fire. Upon arrival, crews found a single-story home with nothing showing. The resident informed crews that a trash can caught fire and was extinguished. Investigation showed a burned trash can with damage to the siding, fascia, down spout, and exterior wiring. Crews checked for extension with no unusual findings. Franklin Township provided mutual aid assistance. The estimated property damage due to fire is \$700.

On 7/3/23 @ 20:32 hours, crews responded to North State Route 48 for a reported vehicle fire. Upon arrival, crews found a vehicle located in a driveway with active fire. Crews established a handline to extinguish the fire. All occupants evacuated the vehicle prior to the crew's arrival. Finding no additional hazards, crews released the scene to Clearcreek PD. The estimated property damage due to fire is \$2,300.

On 7/7/23 @ 16:13 hours, crews responded to a residence for a reported cardiac arrest. Upon arrival, crews found a patient in cardiac arrest. Crews initiated ALS procedures and transported the patient to Atrium Medical Center.



On 7/10/23 @ 03:15 hours, crews responded to Red Lion Five Points Road for a reported vehicle accident with injuries. Upon arrival, crews found a single car off the road into a tree. Ladder 22 and Springboro PD took position to shield the scene. Crews transported one patient to Kettering Health Franklin. Crews secured the site of hazards and released the scene to Clearcreek PD.







On 7/17/23 @ 02:18 hours, crews responded to West Pekin Road for a reported vehicle accident with injuries. Upon arrival, crews found two cars involved in a crash. Crews stabilized the vehicles and assisted the occupants and two dogs out of one vehicle. Crews transported three patients to Atrium Medical Center. Finding no additional hazards, crews released the scene to Clearcreek PD.



On 7/17/23 @ 21:02 hours, crews responded to a mutual aid into Franklin for a reported building collapse. Upon arrival, crews found a residential building that sustained storm damage. Crews noted the structure missing most of the roof but otherwise stable. Crews assisted with salvage and overhaul before returning to service.



On 7/20/23 @ 07:38 hours, crews responded to the UPS store for a reported gas odor. Upon arrival, crews found natural gas readings inside the building. After checking adjacent businesses, crews determined the source of the leak from Thai Silver Spoon. Entry into the restaurant confirmed that a gas line into a stove was leaking. Crews contacted Duke Energy to shut off the gas supply and ensured all pilot lights were off. Crews performed ventilation to the restaurant and adjacent businesses. Duke energy locked out the gas line until repairs were completed.



On 7/22/23 @ 04:05 hours, crews responded to United Dairy Farmers for a reported building fire. Upon arrival, crews found nothing showing and one employee evacuated. The employee informed crews of a burning smell and ashes on an office desk. Upon investigation, crews found smoke haze, fire damage, and ashes in the office area. Crews identified the source as a power strip and checked for extension. Finding no heat signatures, crews ventilated the building. Franklin provided mutual aid assistance. The estimated damage from fire is \$500.



On 7/25/23 @ 09:32 hours, crews responded to a business for a reported seizure and near drowning. Upon arrival, crews found a patient with trouble breathing and head pain from a fall. Crews initiated ALS procedures and transported the patient to Kettering Health Main Campus.

On 7/27/23 @ 18:18 hours, crews responded to a residence for a reported cardiac arrest. Upon arrival, crews determined the patient was DOA. Crews contacted the coroner and released the scene to Springboro PD.

On 7/31/23 @ 10:03 hours, crews responded to Tanglewood Drive for a reported passenger vehicle fire. Upon arrival, crews found a car with fully involved fire in the engine and extension into the passenger compartment. The driver evacuated the building before crew arrival and reported no injuries. Crews used a handline to extinguish the fire. Finding no additional hazards, crews released the scene to Springboro PD. The estimated property damage due to fire is \$3,000.

On 7/31/23 @ 11:29 hours, crews responded to a residence for a reported cardiac arrest. Upon arrival, crews found a patient in cardiac arrest. Crews initiated ALS procedures and transported the patient to Atrium Medical Center.

Firefighter Wilson completed Trench Rescue at the Warren County Career Center.


Special Training
