




Total Alarms


Alarms by Service Type



Response Times



SIGNIFICANT RESPONSES

On 9/1/22 @ 17:28 hours, crews responded to a residence for a reported unconscious/unresponsive person. Upon arrival, crews determined the patient was DOA. Crews contacted the coroner and released the scene to Springboro PD.

On 9/5/22 @ 08:59 hours, crews responded to a residence for a reported non-breather. Upon arrival, crews determined the patient was DOA. Crews contacted the coroner and released the scene to Springboro PD.

On 9/10/22 @ 08:53 hours, crews responded to a nursing home for a reported non-breather. Upon arrival, crews found a patient in cardiac arrest. Crews initiated ALS procedures with no response from the patient. Medical control provided a field termination of resuscitation efforts order. Crews contacted the corner and released the scene to Clearcreek PD.


On 9/18/22 @ 01:46 hours, crews responded to Woodcliff Boulevard for a reported structure fire. Upon arrival, crews found a residence involved in heavy fire, with all occupants evacuated. Due to heavy fire and structural collapse, crews used deck guns to control the fire before initiating hose lines for an interior attack. After extinguishing the fire, crews checked for hotspots and performed overhaul. Washington Township provided mutual aid assistance. The estimated property damage due to fire is \$321,320.

On 9/21/22 @ 13:56 hours, crews responded to State Route 48 for a reported vehicle accident with injuries. Upon arrival, crews found one car involved in a rollover accident. All occupants evacuated the vehicle, and crews transported two patients to Kettering Health Main. After securing the site of hazards, crews released the scene to Ohio State Patrol and Clearcreek PD.

On 9/26/22 @ 15:12 hours, crews responded to Utica Road for a reported brush fire. Upon arrival, crews found a large open burn that spread to surrounding brush with wind fueling the fire. Crews extinguished the fire using water from Engines and Class A Combustible Foam.



On 9/26/22 @ 18:58 hours, crews responded to a residence for a reported non-breather. Upon arrival, crews found a patient in cardiac arrest. Crews initiated ALS procedures and transported the patient to Kettering Health Washington Township.
