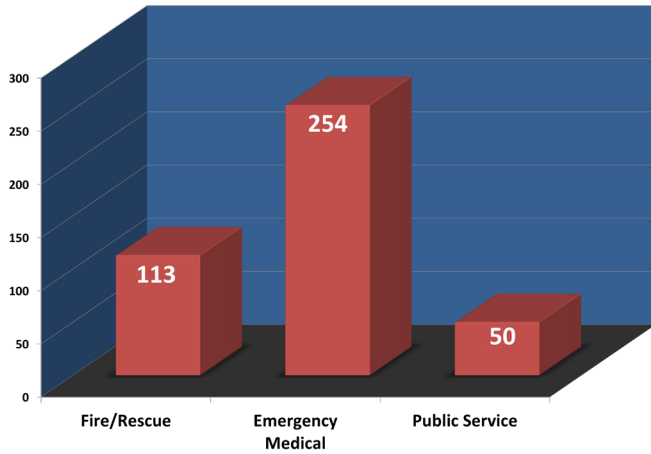

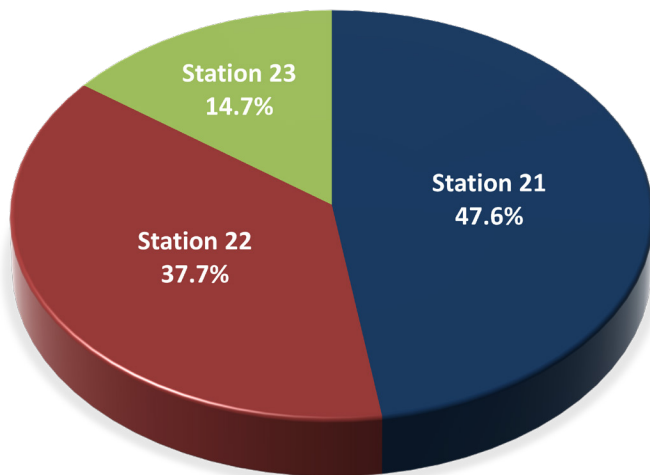
## Alarms by Service Type

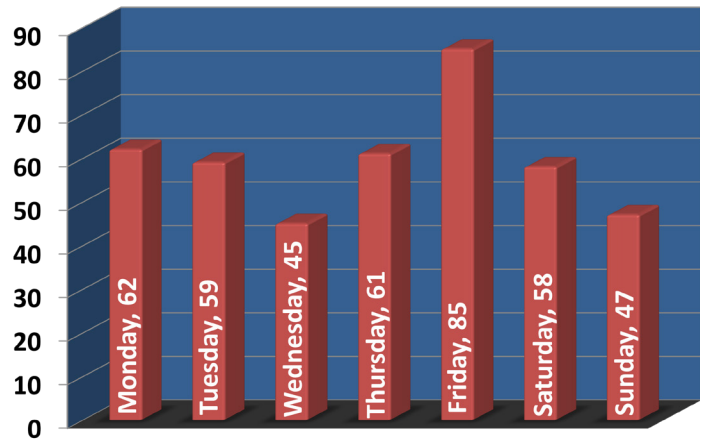
## Response Percentages

## Significant Responses

On 9/1/24 at 10:19 hours, crews responded to a residence for a reported cardiac arrest. Upon arrival, crews determined the patient was DOA. Crews contacted the coroner and released the scene to Clearcreek PD.

On 9/3/24 at 10:19 hours, crews responded to a residence for a reported non-breather. Upon arrival, crews determined the patient was DOA. Crews contacted the coroner and released the scene to Springboro PD.



On 9/6/24 at 11:51 hours, crews responded mutual aid into Lebanon for a reported structure fire. Upon arrival, crews found a multifamily residential structure with heavy smoke showing. Crews performed interior fire suppression and overhaul. After extinguishing the fire and checking for extension, crews re-entered the building and rescued four cats. Crews continued checking for and extinguishing hot spots until released by command.



On 9/7/24 at 17:29 hours, crews responded mutual aid into Wayne Township for a reported structure fire. Upon arrival, crews found a working garage fire with vehicles being moved away from the building. Crews assisted with suppression, overhaul, and extension until released by command.



On 9/8/24 at 14:49 hours, crews responded mutual aid into Wayne Township for a reported drowning. Upon arrival, crews found a patient with post drowning hypothermia. Crews initiated ALS procedures and transported the patient to Dayton Children's Hospital.

On 9/8/24 at 23:00 hours, crews responded to a residence for a reported cooking fire. Upon arrival, crews found a two-story home with nothing showing. The homeowner advised there was a grease fire, which they extinguished. Investigation showed interior haze and a damaged stovetop in the kitchen. Crews also noted fire damage to the microwave and smoke damage on the cabinets. Crews checked for hot spots and performed ventilation. The estimated property damage due to fire is \$1,500.

On 9/12/24 at 18:00 hours, crews responded to a residence for a reported unconscious person. Upon arrival, crews found a patient in cardiac arrest with Clearcreek PD performing CPR. Crews initiated ALS procedures and transported the patient to Kettering Health Main Campus.

On 9/13/24 at 17:22 hours, crews responded to a residence for a reported structure fire. Upon arrival, crews found a residential building with nothing showing. Investigation showed smoke staining, melted siding, and burnt exterior furniture. Additionally, crews found interior smoke but no fire. A neighbor and a family member extinguished the fire using garden hoses and an extinguisher before crew arrived. Crews checked for extension and performed overhaul and ventilation. Miami Valley Fire District provided mutual aid assistance. The estimated property damage due to the fire is \$21,000.



On 9/14/24 at 15:43 hours, crews responded to a residence for a reported brush fire. Upon arrival, crews found a working grass fire. Crews extinguish the fire using a yard line and pressurized water cans. Wayne Township provided mutual aid assistance. The estimated property damage from fire is \$3,000.



On 09/24/24 at 01:13 hours, crews responded to a residence for a reported cardiac arrest. Upon arrival, crews found a patient in cardiac arrest. Crews initiated ALS procedures with no response from the patient. Medical control provided a field termination of resuscitation efforts order. Crews contacted the coroner and released the scene to Clearcreek PD.

On 9/24/24 at 20:22 hours, crews responded to a residence for a reported cardiac arrest. Upon arrival, crews determined the patient was DOA. Crews contacted the coroner and released the scene to Clearcreek PD.
