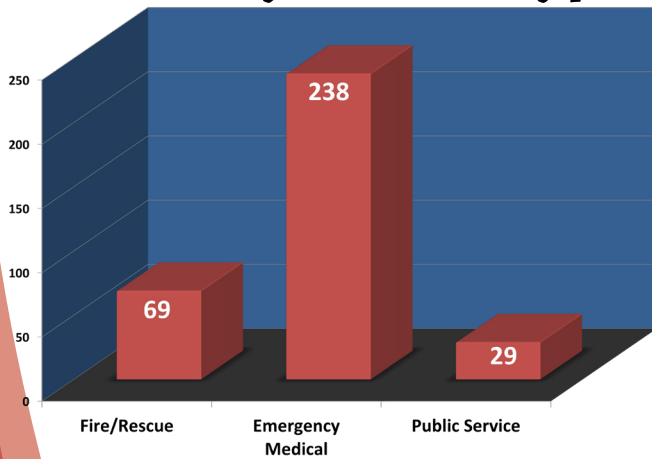

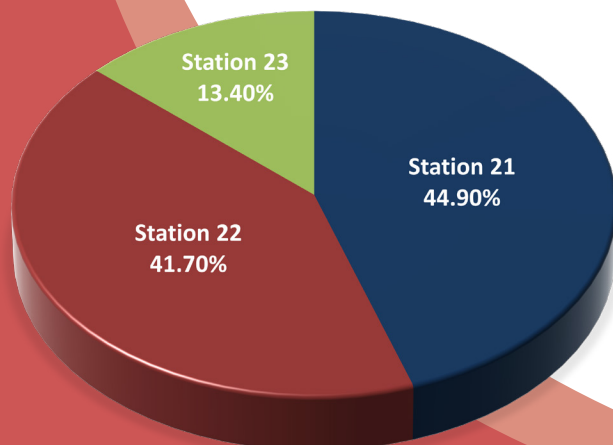
Alarms by Service Type

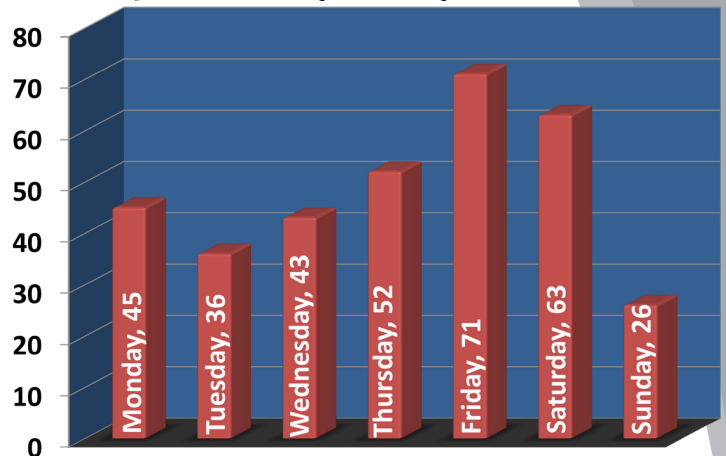
Response Percentages

SIGNIFICANT RESPONSES

On 9/7/23 @ 15:15 hours, crews responded to a residence for a reported suicide attempt. Upon arrival, crews determined the patient was DOA. Crews contacted the coroner and released the scene to Springboro PD.

On 9/8/23 @ 19:03 hours, crews responded to North State Route 48 for a reported vehicle accident with injuries. Upon arrival, crews found three vehicles involved in a crash, with one passenger car into a ditch, another passenger vehicle in the Hidden Valley Orchard driveway, and a third vehicle in the roadway, leaking fluid. Crews stabilized the vehicles and applied drying agent to the roadway. Turtlecreek Township transported two patients. Medic 23 crews transported one patient to Kettering Health Main Campus. Crews secured the site of hazards and released the scene to the Warren County Sherriff's Office. Turtlecreek Township provided mutual aid assistance.



On 9/12/23 @ 08:58 hours, crews responded to West Central Avenue for a reported structure fire at a restaurant. Upon arrival, crews found nothing showing from the exterior. Further investigation showed smoke haze and odor inside the building. Crews performed ventilation and located the source as an HVAC unit on the roof. Crews locked out the faulty unit and checked for heat signatures. Finding no additional hazards, crews released the scene to the restaurant manager. Miami Valley and Franklin provided mutual aid assistance.



On 9/12/23 @ 09:32 hours, crews responded to a nursing home for a reported cardiac arrest. Upon arrival, crews determined the patient was DOA. Crews contacted the coroner and released the scene to Springboro PD.

On 9/15/23 @ 00:10 hours, crews responded to a mutual aid call into Franklin for a reported structure fire. Upon arrival, crews found a manufacturing facility with nothing showing from the exterior. Investigation showed a smoke haze in the interior from a trash compactor that caught fire and was extinguished before crew arrival. Crews assisted in ventilation until released by incident command.

On 9/18/23 @ 13:00 hours, crews responded to a residence for a reported sick person. Upon arrival, crews found a patient disoriented and hypotensive. Crews initiated a stroke alert and transported the patient to Kettering Health Miamisburg.

On 9/20/23 @ 04:30 hours, crews responded to a residence for a reported cardiac arrest. Upon arrival, crews found a patient in cardiac arrest with Clearcreek PD performing CPR. Upon investigation, crews determined the patient was DOA. Crews contacted the coroner and released the scene to Clearcreek PD.
